with Assembly Floor Amendments
(Proposed By Assemblyman COUTINHO)

ADOPTED: NOVEMBER 17, 2008

These floor amendments would permit a municipality that is a city of the second class with a major place of amusement that is privately owned or owned by a county improvement authority, having 10,000 fixed seats or less, to impose a surcharge of up to \$2 on admissions and a surcharge of up to \$2 on parking for the facility. The monies collected from the surcharges are required to be used to fund health and recreational programs and services for senior citizens and youth.
