**SYNOPSIS**

Requires court to issue animal protective orders against persons found guilty of abusing animals.

**CURRENT VERSION OF TEXT**

1 AN ACT concerning the protection of animals from abuse and  
2 supplementing Title 4 of the Revised Statutes.

4 **BE IT ENACTED** by the Senate and General Assembly of the State  
5 of New Jersey:

7 1. a. In addition to the provisions of Title 4 of the Revised  
8 Statutes concerning the confiscation and restrictions on ownership  
9 of animals, the court, upon finding a person guilty of abusing an  
10 animal or otherwise violating the State animal cruelty laws, may  
11 issue an animal protection order against the person adjudged guilty  
12 of the abuse or other violation, requiring the person to refrain from  
13 interacting with an animal permanently or for a period of time  
14 specified by the court. The animal protection order may apply to a  
15 specific animal with which the adjudged person has had contact, or  
16 any other animal, as determined to be appropriate by the court.

17 b. Any person who knowingly violates a condition of an animal  
18 protection order issued pursuant to this section, and, as a result,  
19 causes injury to the animal that is the subject of the animal  
20 protection order, shall be guilty of a disorderly persons offense.

22 2. This act shall take effect immediately.

STATEMENT

27 This bill would authorize a court, upon finding a person guilty of  
28 abusing an animal or otherwise violating the State animal cruelty  
29 laws, to issue an animal protection order against the person  
30 adjudged guilty of the abuse or other violation. The animal  
31 protection order would require the person to refrain from interacting  
32 with an animal permanently or for a period of time specified by the  
33 court. The animal protection order may apply to a specific animal  
34 with which the adjudged person has contact, or to any other animal,  
35 as determined to be appropriate by the court.

36 The bill would also provide that whenever a person knowingly  
37 violates the conditions of an animal protection order and, as a  
38 result, causes injury to the animal that is the subject of the animal  
39 protection order, the person would be guilty of a disorderly persons  
40 offense.
