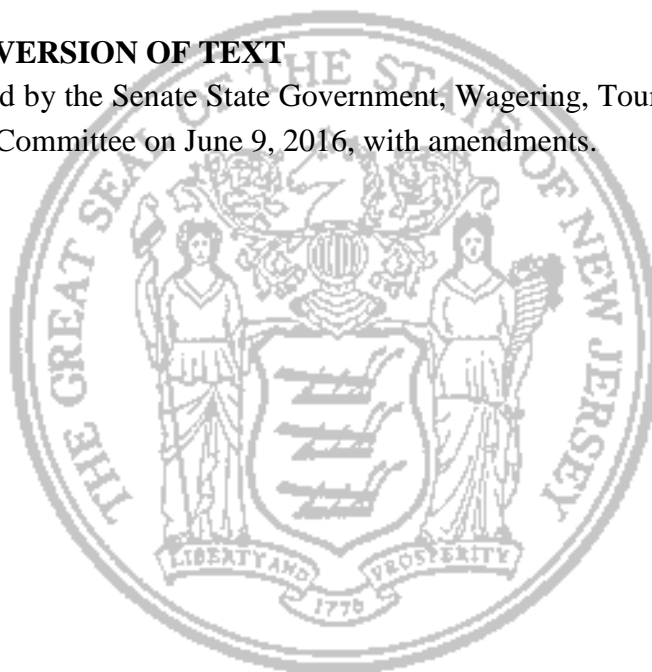

**SYNOPSIS**

Provides that PERS or PFRS member who continues to be volunteer firefighter or emergency services worker after retirement with employer from whom member retires has bona fide severance for compliance with State and federal law.

7 **BE IT ENACTED** by the Senate and General Assembly of the State  
8 of New Jersey:

10 1. The retirement of a member of the Public Employees'  
11 Retirement System, established pursuant to P.L.1954,  
12 c.84 (C.43:15A-1 et seq.), who (1) on the date of retirement has  
13 attained the service retirement age applicable to that member and is  
14 a volunteer firefighter <sup>1</sup>or first aid worker, rescue squad worker, or  
15 emergency medical technician serving as a volunteer<sup>1</sup> with the same  
16 employer from whose employment the member retires; and (2)  
17 remains a volunteer firefighter <sup>1</sup>or first aid worker, rescue squad  
18 worker, or emergency medical technician serving as a volunteer<sup>1</sup>  
19 after the date of retirement, shall be a bona fide severance from  
20 employment, notwithstanding that the retired employee maintains  
21 the relationship of a volunteer firefighter <sup>1</sup>or first aid worker, rescue  
22 squad worker, or emergency medical technician serving as a  
23 volunteer<sup>1</sup> with the same employer from whose employment the  
24 member retired. This act shall be effective if the qualified status of  
25 the retirement system under federal law can be maintained upon its  
26 application, and such modifications to the system as may be  
27 available shall be made to allow for its application.

30 Retirement System, established pursuant to P.L.1944,

37 worker, or emergency medical technician serving as a volunteer<sup>1</sup>
