The New Jersey Citizens' Clean Elections Commission will meet on Tuesday, April 26, 2005 between 3:00 and 5:00 PM in Traves Hall, Room B, Douglass College, Rutgers University, New Brunswick, New Jersey.

The commission will receive a briefing by officials from the New Jersey Election Law Enforcement Commission (ELEC) on how it plans to administer P.L. 2004, c. 121 (the New Jersey Fair and Clean Elections Pilot Project) for candidates participating in the project during the November 8, 2005 General Election. This will be followed by an open discussion among commission members and staff on all aspects of the Clean Elections Pilot Project. Comments and questions from the public will be entertained.

Directions

From the New Jersey Turnpike (north or south):

Take Exit 9 to Route 18 North. Take the first exit for George Street (Cook/Douglass Campus) which is after the traffic light at Paulus Boulevard. Follow George Street to the second traffic light. Turn left on Nichol Avenue. At Co-op Bookstore, turn left on Lipman Drive. Immediately turn left again into the **College Center parking lot (this surface parking is for commission members only with identification such as a Driver License or office id.)** Proceed to rear entrance to Douglass College Center. Information center attendant will direct you to Traves Hall, Room B.

From Garden State Parkway South:

Take Exit 129 to NJ Turnpike South to Exit 9. Follow New Jersey Turnpike directions from this point.

From Garden State Parkway North:

Take Exit 105 to Route 18 North. Follow NJ Turnpike directions from this point.
