1 **A CONCURRENT RESOLUTION** designating May 16 through 22,
2 2010, as "Emergency Medical Services Week."

4 **WHEREAS**, The emergency medical services professionals of New
5 Jersey unselfishly give their time and effort to travel significant
6 distances in order to provide medical assistance and often risk their
7 lives to aid people in need; and

8 **WHEREAS**, Immediate emergency medical response and access to
9 quality medical care dramatically improves the survival and
10 recovery rate of persons who experience sudden illness or injury;
11 and

12 **WHEREAS**, Emergency medical services professionals, whether career
13 or volunteer, engage in thousands of hours of specialized training
14 and continuing education to enhance their skills; and

15 **WHEREAS**, Residents of the State of New Jersey take solace in the
16 knowledge that, should a medical emergency arise, well-trained
17 professionals are available to render efficient and effective
18 assistance; and

19 **WHEREAS**, The difficult tasks undertaken by emergency medical
20 services professionals dramatically improve the overall health and
21 well-being of the citizens of the State of New Jersey; and

22 **WHEREAS**, It is, therefore, fitting and proper to recognize the value
23 and accomplishments of emergency medical services professionals
24 as well as their integral role in emergency response; now, therefore,

26 **BE IT RESOLVED** by the Senate of the State of New Jersey (the
27 General Assembly concurring):

29 1. The week of May 16 through 22, 2010, is designated as
30 "Emergency Medical Services Week" to commend all emergency
31 medical services professionals in New Jersey for their tireless
32 efforts and services to the State.

34 2. The Governor is requested to issue a proclamation calling
35 upon public officials and the citizens of this State to observe
36 "Emergency Medical Services Week" with appropriate activities
37 and programs.

39 3. Duly authenticated copies, signed by the President of the
40 Senate and the Speaker of the General Assembly and attested by the
41 Secretary of the Senate and the Clerk of the General Assembly shall
42 be transmitted to the Governor.
