SYNOPSIS

Prohibits mail order, Internet, telephone, and any other anonymous method of ammunition sale or transfer in New Jersey.

1 AN ACT concerning the sale of ammunition and supplementing Title
2 2C of the New Jersey Statutes.

4 **BE IT ENACTED** by the Senate and General Assembly of the State
5 of New Jersey:

7 1. a. All ammunition sales and transfers shall be consummated
8 as face-to-face transactions between the seller, transferor, or
9 assigner and the purchaser, or assignee. As used in this section,
10 face-to-face transaction means a sale or transfer in which the
11 purchaser, transferee, or assignee is in the physical presence of the
12 seller, transferor, or assigner at the time the sale or transfer is
13 consummated. It shall not include any transaction conducted by
14 mail order, the Internet, telephone, or any other anonymous method
15 of transaction in which the two parties are not in each other's
16 physical presence.

17 b. Each person purchasing or receiving ammunition shall, at
18 the time of sale or transfer, display a valid form of picture
19 identification, setting forth the purchaser or recipient's name,
20 address, and date of birth.

21 c. The provisions of this section shall not apply to any person
22 licensed pursuant to federal law or under chapter 58 of Title 2C of
23 the New Jersey Statutes, a collector of firearms or ammunition as
24 curios or relics who purchases, receives, acquires, or transfers
25 ammunition which is recognized as being historical in nature or of
26 historical significance, or to any sale, transfer, assignment, or
27 disposition of ammunition to or any purchase, receipt, or acceptance
28 of ammunition by a law enforcement agency or law enforcement
29 official for law enforcement purposes.

30 d. With regard to the sale and transfer of handgun ammunition,
31 the provisions of this section are in addition to the requirements set
32 forth under section 1 of P.L.2007, c.318 (C.2C:58-3.3).

33 e. A person who violates this section shall be guilty of a crime
34 of the fourth degree.

36 2. This act shall take effect on the first day of the second month
37 following enactment.

STATEMENT

42 This bill would make mail order, Internet, telephone, and any
43 other anonymous method of ammunition sale or transfer illegal in
44 New Jersey

45 The provisions of the bill require that all ammunition sales and
46 transfers be consummated as face-to-face transactions and that at
47 the time of the sale or transfer the purchaser or recipient display a
48 valid form of picture identification to the person selling or

1 transferring the ammunition. Face-to-face transactions are defined
2 as sales or transfers in which the purchaser, transferee, or assignee
3 is in the physical presence of the seller, transferor, or assigner.

4 Under the bill, a violator would be guilty of a crime of the fourth
5 degree. A crime of the fourth degree is punishable by imprisonment
6 for a term of up to 18 months, a fine of up to \$10,000, or both.

7 Federal and State licensees and dealers, law enforcement
8 agencies and officials, and collectors when purchasing, acquiring,
9 or transferring ammunition which is recognized as being historical
10 in nature or of historical significance, are exempted from the
11 provisions of the bill.
