BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

- Upon proper application, the Chief Administrator of the New Jersey Motor Vehicle Commission shall issue Combat Action Badge license plates for any motor vehicle owned or leased and registered in this State. In addition to the registration number and other markings or identification otherwise prescribed by law, the license plate shall display the words, "Combat Action Badge" and depict the Combat Action Badge emblem. The chief administrator, in consultation with the Adjutant General of the New Jersey Department of Military and Veterans Affairs, shall select the design of the Combat Action Badge license plates. The Combat Action Badge license plates shall be subject to the provisions of chapter 3 of Title 39 of the Revised Statutes, except as hereinafter otherwise specifically provided.
- b. Application for issuance of a Combat Action Badge license plate shall be made to the chief administrator on forms and in a manner prescribed by the chief administrator. The application shall include proof satisfactory to the chief administrator that the applicant is a holder of the Combat Action Badge as certified on the applicant's DD-214 form or on a Certificate of Release or Discharge from Active Duty. In order to be deemed complete, an application shall be accompanied by a fee of \$50, payable to the New Jersey Motor Vehicle Commission, which shall be in addition to the fee otherwise prescribed by law for the registration of motor vehicles. The chief administrator shall collect annually, subsequent to the year of issuance of the Combat Action Badge license plate, a \$10 fee for the license plate in addition to the fee otherwise prescribed by law for the registration of a motor vehicle. The additional fees required by this subsection shall be deposited in the "Combat Action Badge License Plate Fund" created pursuant to subsection c. of this section.
- There is created in the Department of Treasury a special non-lapsing fund to be known as the "Combat Action Badge License Plate Fund." There shall be deposited in the fund the amount collected from all license plate fees collected pursuant to subsection b. of this section, less the amounts necessary to reimburse the commission for administrative costs pursuant to subsection d. of this section. Monies deposited in the fund shall be appropriated annually to the New Jersey Department of Military and Veterans Affairs and shall be used to support programs benefiting combat veterans. Monies deposited in the fund shall be held in interest-bearing accounts in public depositories as defined pursuant to section 1 of P.L.1970, c.236 (C.17:9-41), and may be

- 1 invested or reinvested in securities approved by the State Treasurer.
- 2 Interest or other income earned on monies deposited into the fund,
- and any monies which may be appropriated or otherwise become
- 4 available for the purposes of the fund, shall be credited to and
- 5 deposited in the fund for use as set forth in P.L., c. (C.)
- 6 (pending before the Legislature as this bill).

- d. Prior to the deposit of the additional fees collected pursuant to subsection b. of this section into the "Combat Action Badge License Plate Fund," amounts thereof as are necessary shall be used to reimburse the commission for all costs reasonably and actually incurred, as stipulated by the chief administrator, for:
- (1) producing, issuing, renewing, and publicizing the availability of the Combat Action Badge license plates; and
- (2) any computer programming changes that may be initially necessary to implement the Combat Action Badge license plate program established by P.L. , c. (C.) (pending before the Legislature as this bill), in an amount not to exceed \$150,000.

The chief administrator shall annually certify to the State Treasurer the average cost per license plate incurred in the immediately preceding year by the commission in producing, issuing, renewing, and publicizing the availability of the Combat Action Badge license plates. The annual certification of the average cost per license plate shall be approved by the Joint Budget Oversight Committee, or its successor.

In the event that the average cost per license plate as certified by the chief administrator and approved by the Joint Budget Oversight Committee, or its successor, is greater than the \$50 application fee established in subsection b. of this section in two consecutive fiscal years, the chief administrator may discontinue the issuance of Combat Action Badge license plates.

- e. The chief administrator shall notify eligible motorists of the opportunity to obtain Combat Action Badge license plates by publicizing the availability of the license plates on the website of the commission. The New Jersey Department of Military and Veterans Affairs, and any other individual or entity designated by the department, may publicize the availability of the Combat Action Badge license plates in any manner that the department deems appropriate.
- f. The chief administrator and adjutant general shall develop and enter into an inter-departmental memorandum of agreement setting forth the procedures to be followed in carrying out their respective responsibilities under P.L. , c. (C.) (pending before the Legislature as this bill).
- g. The adjutant general shall appoint a representative who shall act as a liaison between the department and the commission. The liaison shall represent the department in any and all communications with the commission regarding the Combat Action

- 2. a. No State or public funds shall be used by the commission for the initial cost of:
- 6 (1) producing, issuing, and publicizing the availability of 7 Combat Action Badge license plates; or
 - (2) any computer programming changes which may be necessary to implement the Combat Action Badge license plate program established by P.L. , c. (C.) (pending before the Legislature as this bill).
- 12 b. The New Jersey Department of Military and Veterans 13 Affairs, or other individual or entity designated by the department, 14 shall contribute non-public monies in an amount to be determined 15 by the chief administrator, not to exceed a total of \$25,000, to be used to offset the initial costs incurred by the commission for 16 17 producing, issuing, and publicizing the availability of Combat 18 Action Badge license plates, and any computer programming which 19 may be necessary to implement the program. 20 organizations and individual donors may contribute monies to the 21 department to be used to offset the initial costs incurred by the 22 commission for the Combat Action Badge license plates authorized 23 by P.L., c. (C.) (pending before the Legislature as this 24 bill),. Any amount remaining after the payment of the initial cost 25 shall be deposited in the "Combat Action Badge License Plate 26 Fund" established pursuant to subsection c. of section 1 of 27 P.L. , c. (C.) (pending before the Legislature as this bill). The commission shall not begin designing, producing, 28 29 issuing, or publicizing the availability of the Combat Action Badge 30 license plates, or making any necessary computer programming 31 changes until the department has provided the commission with the 32 money necessary, as determined by the chief administrator pursuant 33 to subsection b. of this section, to offset the initial costs incurred by 34 the commission in establishing the Combat Action Badge license
