SYNOPSIS

Requires certain public contract bid advertisements to contain certified cost estimate ranges, specifies grounds for rejection of all bids, and requires 50% guaranty on bids; designated as the Fairness in Bidding Act.

1 AN ACT concerning certain bid advertising requirements for State,
2 State college, county college, school, and local public
3 construction contracts and designated as the Fairness in Bidding
4 Act, and amending and supplementing various parts of the
5 statutory law.

7 **BE IT ENACTED** by the Senate and General Assembly of the State
8 of New Jersey:

9

10 1. N.J.S.18A:18A-21 is amended to read as follows:

11 18A:18A-21. a. Except as provided in section 5 of
12 P.L.1985, c.490 (C.18A:18A-55), all advertisements for bids shall
13 be published in an official newspaper sufficiently in advance of the
14 date fixed for receiving the bids to promote competitive bidding,
15 but in no event less than 10 days prior to such date. For all
16 contracts, the date fixed for receiving the bids shall not fall on a
17 Monday, or any day directly following a State or federal holiday.
18 The advertisement for bids for construction projects projected to
19 cost in excess of \$500,000 shall include the board of education's or
20 its purchasing agent's projected cost estimate ranges for the base bid
21 contract and any specified alternate proposal, such estimate ranges
22 having been attested to as reasonable by the individual or firm
23 preparing the cost estimate ranges. The highest amount of a cost
24 estimate range shall not be greater than five percent more than the
25 lowest amount. The projected cost estimate ranges shall be attested
26 no more than 30 days prior to the bid advertisement date.

27 For purposes of this subsection:

28 "Specified alternate proposal" means a requirement of the bid
29 specification for bidders to submit prices for reduced, modified, or
30 supplemental work in addition to the base proposal which may
31 include, but not be limited to, a change in project scope or the use
32 of alternative materials or methods of construction.

33 b. The advertisement shall designate the manner of submitting
34 and of receiving the bids and the time and place at which the bids
35 will be received. If the published specifications provide for receipt
36 of bids by mail or hand delivery, only one copy of the bid
37 documents shall be required, and those bids which are mailed to the
38 board of education shall be sealed and shall be opened only for
39 examination at such time and place as all bids received are unsealed
40 and announced. At such time and place the purchasing agent of the
41 board of education shall publicly receive the bids and thereupon
42 immediately proceed to unseal them and publicly announce the
43 contents, which announcement shall be made in the presence of any
44 parties bidding or their agents who are then and there present. A
45 proper record of the prices and terms shall be made in the minutes

2 the advertisement.

3 c. Notice of revisions or addenda to advertisements or bid
4 documents shall be provided as follows:

5 (1) For all contracts except those for construction work, notice
6 shall be published no later than seven days, Saturdays, Sundays, and
7 holidays excepted, prior to the date for acceptance of bids, in an
8 official newspaper of the board of education and be provided to any
9 person who has submitted a bid or who has received a bid package,
10 in one of the following ways: (a) in writing by certified mail or (b)
11 by certified facsimile transmission, meaning that the sender's
12 facsimile machine produces a receipt showing date and time of
13 transmission and that the transmission was successful or (c) by a
14 delivery service that provides certification of delivery to the sender.

15 (2) For all contracts for construction work, notice shall be
16 provided no later than seven days, Saturdays, Sundays, or holidays
17 excepted, prior to the date for acceptance of bids, to any person who
18 has submitted a bid or who has received a bid package in any of the
19 following ways: i) in writing by certified mail or ii) by certified
20 facsimile transmission, meaning that the sender's facsimile machine
21 produces a receipt showing date and time of transmission and that
22 the transmission was successful or iii) by a delivery service that
23 provides certification of delivery to the sender.

24 d. Failure of the board of education to advertise for the receipt
25 of bids or to provide proper notification of revisions or addenda to
26 advertisements or bid documents related to bids as prescribed by
27 this section shall prevent the board of education from accepting the
28 bids and require the readvertisement for bids pursuant to subsection
29 a. of this section. Failure to obtain a receipt when good faith notice
30 is sent or delivered to the address or telephone facsimile number on
31 file with the board of education shall not be considered failure by
32 the board of education to provide notice.

35 2. N.J.S.18A:18A-22 is amended to read as follows:

36 18A:18A-22. Rejection of bids. A board of education may
37 reject all bids only for any of the following publicly stated bona
38 fide reasons:

39 a. The lowest bid substantially exceeds the published and
40 attested cost estimates or estimate ranges for the goods or services;

41 b. The lowest bid substantially exceeds the board of education's
42 appropriation, if any, for the goods or services;

43 c. The board of education decides to abandon the project for
44 provision or performance of the goods or services;

45 d. The board of education wants to substantially revise the scope
46 and specifications for the goods or services;

47 e. The purposes or provisions or both of N.J.S.18A:18A-1 et
48 seq. are being violated; and

1 f. The board of education decides to use the State authorized
2 contract pursuant to N.J.S.18A:18A-10.

5 3. N.J.S.A.18A:18A-24 is amended to read as follows:

6 18A:18A-24. Security to accompany bid; amount. There may be
7 required from any person bidding on any contract, advertised in
8 accordance with law, that the bid be accompanied by a guarantee
9 payable to the board of education that, if the contract is awarded to
10 the bidder, the bidder will enter into a contract therefor and will
11 furnish any performance bond or other security required as a
12 guarantee or indemnification. The guarantee shall be in the amount
13 of ~~【10%】~~ 50% of the bid, but not in excess of ~~【\$20,000.00】~~
14 \$100,000, except as otherwise provided herein, and may be given,
15 at the option of the bidder, by certified check, cashier's check or bid
16 bond. In the event that any law or regulation of the United States
17 imposes any condition upon the awarding of a monetary grant to
18 any board of education, which condition requires the depositing of a
19 guarantee in an amount other than ~~【10%】~~ 50% of the bid or in
20 excess of ~~【\$20,000.00】~~ \$100,000, the provisions of this section
21 shall not apply and the requirements of the law or regulation of the
22 United States shall govern.

25 4. Section 14 of P.L.1986, c.43 (C.18A:64-65) is amended to
26 read as follows:

27 14. a. All advertisements for bids shall be published in a legal
28 newspaper sufficiently in advance of the date fixed for receiving the
29 bids to promote competitive bidding but in no event less than 10
30 days prior to that date for any construction projects or any other
31 contract or purchase. In addition to being published in a legal
32 newspaper, advertisements may also be posted using electronic data
33 or media services, including the internet. The advertisement for
34 bids for construction projects projected to cost in excess of
35 \$500,000 shall include the State college's or its purchasing agent's
36 projected cost estimate ranges for the base bid contract and any
37 specified alternate proposal, such estimate ranges having been
38 attested to as reasonable by the individual or firm preparing the cost
39 estimate ranges. The highest amount of a cost estimate range shall
40 not be greater than five percent more than the lowest amount. The
41 projected cost estimate ranges shall be attested no more than 30
42 days prior to the bid advertisement date. The advertisement shall
43 designate the manner of submitting and of receiving the bids and
44 the time and place at which the bids will be received. If the
45 published specifications provide for receipt of bids by mail or hand
46 delivery, only one copy of the bid documents shall be required, and

20 received a bid package, in one of the following ways: (a) in writing
21 by certified mail or (b) by certified facsimile transmission, meaning
22 that the sender's facsimile machine produces a receipt showing date
23 and time of transmission and that the transmission was successful or
24 (c) by a delivery service that provides certification of delivery to the
25 sender. Failure to advertise or provide proper notification of
26 revisions or addenda to advertisements or bid documents related to
27 bids as prescribed by this section shall prevent the acceptance of
28 bids and require the readvertisement for bids.

29 Failure to obtain a receipt when good faith notice is sent or
30 delivered to the address or telephone facsimile number on file with
31 the State college shall not be considered failure by the State college
32 to provide notice.

35 5. Section 15 of P.L.1986, c.43 (C.18A:64-66) is amended to
36 read as follows:

37 15. No bid shall be accepted which does not conform to the
38 specifications furnished therefor. Nothing contained in this article
39 shall be construed as depriving any State college of the right to
40 reject all bids except that in the case of bids for construction
41 projects, the State college may reject all bids only for any of the
42 following publicly stated bona fide reasons:

43 a. The lowest bid substantially exceeds the published and
44 attested cost estimates or estimate ranges for the construction
45 project;

46 b. The lowest bid substantially exceeds the State college's
47 appropriation, if any, for the construction project;

48 c. The State college decides to abandon the construction project;

1 d. The State college wants to substantially revise the scope and
2 specifications for the construction project;

3 e. Either the purposes or provisions, or both, of the "State
4 College Contracts Law," P.L.1986, c.43 (C.18A:64-52 et seq.) are
5 being violated; and

6 f. The State college decides to use the State authorized contract
7 pursuant to section 9 of P.L.1986, c.43 (C.18A:64-60).
8 (cf: P.L.1986, c.43, s.15)

10 6. Section 16 of P.L.1986, c.43 (C.18A:64-67) is amended to
11 read as follows:

12 16. There may be required from any person bidding on any
13 purchase, contract or agreement, advertised in accordance with law,
14 that the bid be accompanied by a guaranty payable to the State
15 college that, if the purchase, contract or agreement is awarded to
16 him, he will enter into a contract therefor. The guaranty shall be in
17 the amount of ~~【10%】~~ 50% of the bid but not in excess of
18 ~~【\$20,000.00】~~ \$100,000, except as otherwise provided herein, and
19 may be given, at the option of the bidder, by certified check,
20 cashier's check or bid bond. For a construction contract the
21 guaranty shall be in the amount of ~~【10%】~~ 50% of the bid. In the
22 event that any law or regulation of the United States imposes any
23 condition upon the awarding of a monetary grant to any State
24 college, which condition requires a guaranty in an amount other
25 than ~~【10%】~~ 50% of the bid or in excess of ~~【\$20,000.00】~~ \$100,000,
26 the provisions of this section shall not apply and the requirements
27 of the law or regulation of the United States shall govern.

28 The college may require a bid guaranty alone without also
29 requiring a performance bond or other security in the contract.
30 (cf: P.L.2005, c.369, s.9)

32 7. Section 14 of P.L.1982, c.189 (C.18A:64A-25.14) is amended
33 to read as follows:

34 14. a. All advertisements for bids shall be published in a legal
35 newspaper sufficiently in advance of the date fixed for receiving the
36 bids to promote competitive bidding but in no event less than 10
37 days prior to such date. The advertisement for bids for construction
38 projects projected to cost in excess of \$500,000 shall include the
39 county college's or its purchasing agent's projected cost estimate
40 ranges for the base bid contract and any specified alternate
41 proposal, such estimate ranges having been attested to as reasonable
42 by the individual or firm preparing the cost estimate ranges. The
43 highest amount of a cost estimate range shall not be greater than
44 five percent more than the lowest amount. The projected cost
45 estimate ranges shall be attested no more than 30 days prior to the
46 bid advertisement date. The advertisement shall designate the

42 shall be construed as depriving any county college of the right to
43 reject all bids except that in the case of bids for construction
44 projects, a county college may reject all bids only for any of the
45 following publicly stated bona fide reasons:

46 a. The lowest bid substantially exceeds the published and
47 attested cost estimates or estimate ranges for the construction
48 project;

- 1 **b. The lowest bid substantially exceeds the county college's**
2 **appropriation, if any, for the construction project;**
3 **c. The county college decides to abandon the construction**
4 **project;**
5 **d. The county college wants to substantially revise the scope and**
6 **specifications for the construction project;**
7 **e. Either the purposes or provisions, or both, of the "County**
8 **College Contracts Law," P.L.1982, c.189 (C.18A:64A-25.1 et seq.)**
9 **are being violated; and**
10 **f. The county college decides to use the State authorized**
11 **contract pursuant to section 9 of P.L.1982, c.189 (C.18A:64A-25.9).**
12 **(cf: P.L.1982, c.189, s.15)**

14 9. Section 16 of P.L.1982, c.189, s.16 (C.18A:64A-25.16) is
15 amended to read as follows:

16 There may be required from any person bidding on any purchase,
17 contract or agreement, advertised in accordance with law, that the
18 bid be accompanied by a guaranty payable to the county college
19 that, if the purchase, contract or agreement is awarded to him, he
20 will enter into a contract therefor and will furnish any performance
21 bond or other security which may be required pursuant to section
22 17. The guaranty shall be in the amount of **【10%】** 50% of the bid
23 but not in excess of **【\$20,000.00】** \$100,000, except as otherwise
24 provided herein, and may be given, at the option of the bidder, by
25 certified check, cashier's check or bid bond. For a construction
26 contract the guaranty shall be in the amount of **【10%】** 50% of the
27 bid. In the event that any law or regulation of the United States
28 imposes any condition upon the awarding of a monetary grant to
29 any county college, which condition requires a guaranty in an
30 amount other than **【10%】** 50% of the bid or in excess of
31 **【\$20,000.00】** \$100,000, the provisions of this section shall not
32 apply and the requirements of the law or regulation of the United
33 States shall govern.

34 The college may require a bid guaranty alone without also
35 requiring a performance bond or other security in the contract.
36 (cf: P.L.1984, c.241, s.5)

38 10. Section 21 of P.L.1999, c.440 (C.40A:11-13.2) is amended
39 to read as follows:

40 21. A contracting unit may reject all bids only for any of the
41 following publicly stated bona fide reasons:

- 42 a. The lowest bid substantially exceeds the published and
43 attested cost estimates or estimate ranges for the goods or services;
44 b. The lowest bid substantially exceeds the contracting unit's
45 appropriation, if any, for the goods or services;

1 c. The governing body of the contracting unit decides to
2 abandon the project for provision or performance of the goods or
3 services;

4 d. The contracting unit wants to substantially revise the scope
5 and specifications for the goods or services;

6 e. The purposes or provisions or both of P.L.1971, c.198
7 (C.40A:11-1 et seq.) are being violated; and

8 f. The governing body of the contracting unit decides to use the
9 State authorized contract pursuant to section 12 of P.L.1971, c.198
10 (C.40A:11-12).

11 (cf: P.L.1999, c.440, s.21)

12

13 11. Section 21 of P.L.1971, c.198 (C.40A:11-21) is amended to
14 read as follows:

15 21. A person bidding on a contract for the erection, alteration or
16 repair of a public building, structure, facility or other improvement
17 to real property, the total price of which exceeds \$100,000, shall
18 furnish a guarantee as provided for herein. A contracting unit may
19 provide that a person bidding on any other contract, advertised in
20 accordance with law, shall furnish a guarantee as provided for
21 herein. The guarantee shall be payable to the contracting unit so
22 that if the contract is awarded to the bidder, the bidder will enter
23 into a contract therefor and will furnish any performance bond or
24 other security required as a guarantee or indemnification. The
25 guarantee shall be in the amount of ~~【10%】~~ 50% of the bid, but not
26 in excess of ~~【\$20,000.00】~~ \$100,000, except as otherwise provided
27 herein, and may be given, at the option of the bidder, by certified
28 check, cashier's check or bid bond. In the event that any law or
29 regulation of the United States imposes any condition upon the
30 awarding of a monetary grant to any contracting unit, which
31 condition requires the depositing of a guarantee in an amount other
32 than ~~【10%】~~ 50% of the bid or in excess of ~~【\$20,000.00】~~ \$100,000
33 the provisions of this section shall not apply and the requirements
34 of the law or regulation of the United States shall govern.

35 (cf: P.L.1999, c.440, s.29)

37 12. Section 23 of P.L.1971, c.198 (C.40A:11-23) is amended to
38 read as follows:

39 23. a. All advertisements for bids shall be published in an
40 official newspaper of the contracting unit sufficiently in advance of
41 the date fixed for receiving the bids to promote competitive
42 bidding, but in no event less than 10 days prior to such date; except
43 that all advertisements for bids on contracts for the collection and
44 disposal of municipal solid waste shall be published in an official
45 newspaper of the contracting unit circulating in the county or
46 municipality, and in at least one newspaper of general circulation
47 published in the State, sufficiently in advance of the date fixed for
48 receiving the bids to promote competitive bidding, but not less than

1 60 days prior to that date. For all contracts, the date fixed for
2 receiving the bids shall not fall on a Monday, or any day directly
3 following a State or federal holiday. The advertisement for bids for
4 construction projects projected to cost in excess of \$500,000 shall
5 include the contracting unit's or its purchasing agent's projected cost
6 estimate ranges for the base bid contract and any specified alternate
7 proposal, such estimate ranges having been attested to as reasonable
8 by the individual or firm preparing the cost estimate ranges. The
9 highest amount of a cost estimate range shall not be greater than
10 five percent more than the lowest amount. The projected cost
11 estimate ranges shall be attested no more than 30 days prior to the
12 bid advertisement date.

13 b. The advertisement shall designate the manner of submitting
14 and the method of receiving the bids and the time and place at
15 which the bids will be received. If the published specifications
16 provide for receipt of bids by mail or hand delivery, only one copy
17 of the bid documents shall be required, and those bids which are
18 mailed to the contracting unit shall be sealed and shall only be
19 opened for examination at such time and place as all bids received
20 are unsealed and announced. At such time and place the contracting
21 agent of the contracting unit shall publicly receive the bids, and
22 thereupon immediately proceed to unseal them and publicly
23 announce the contents, which announcement shall be made in the
24 presence of any parties bidding or their agents, who are then and
25 there present, and shall also make proper record of the prices and
26 terms, upon the minutes of the governing body, if the award is to be
27 made by the governing body of the contracting unit, or in a book
28 kept for that purpose, if the award is to be made by other than the
29 governing body, and in such latter case it shall be reported to the
30 governing body of the contracting unit for its action thereon, when
31 such action thereon is required. No bids shall be received after the
32 time designated in the advertisement.

33 c. Notice of revisions or addenda to advertisements or bid
34 documents shall be provided as follows:

35 1) For all contracts except those for construction work and
36 municipal solid waste collection and disposal service, notice shall
37 be published no later than seven days, Saturdays, Sundays, and
38 holidays excepted, prior to the date for acceptance of bids, in an
39 official newspaper of the contracting unit and be provided to any
40 person who has submitted a bid or who has received a bid package,
41 in one of the following ways: i) in writing by certified mail or ii)
42 by certified facsimile transmission, meaning that the sender's
43 facsimile machine produces a receipt showing date and time of
44 transmission and that the transmission was successful or iii) by a
45 delivery service that provides certification of delivery to the sender.

46 2) For all contracts for construction work, notice shall be
47 provided no later than seven days, Saturdays, Sundays, or holidays
48 excepted, prior to the date for acceptance of bids, to any person who

1 has submitted a bid or who has received a bid package in any of the
2 following ways: i) in writing by certified mail or ii) by certified
3 facsimile transmission, meaning that the sender's facsimile machine
4 produces a receipt showing date and time of transmission and that
5 the transmission was successful or iii) by a delivery service that
6 provides certification of delivery to the sender.

7 3) For municipal solid waste collection and disposal contracts,
8 notice shall be published in an official newspaper of the contracting
9 unit and in at least one newspaper of general circulation published
10 in the State no later than seven days, Saturdays, Sundays, and
11 holidays excepted, prior to the date for acceptance of bids.

12 d. Failure of the contracting unit to advertise for the receipt of
13 bids or to provide proper notification of revisions or addenda to
14 advertisements or bid documents related to bids as prescribed by
15 this section shall prevent the contracting unit from accepting the
16 bids and require the readvertisement for bids pursuant to subsection
17 a. of this section. Failure to obtain a receipt when good faith notice
18 is sent or delivered to the address or telephone facsimile number on
19 file with the contracting unit shall not be considered failure by the
20 contracting unit to provide notice.

21 (cf: P.L.2007, c.4, s.1)

22
23 13. Section 9 of P.L.2007, c.137 (C.52:18A-243) is amended to
24 read as follows.

25 9. a. In undertaking any school facilities projects where the cost
26 of construction, reconstruction, rehabilitation or improvement will
27 exceed \$25,000, the development authority may prepare, or cause to
28 be prepared, separate plans and specifications for: (1) the plumbing
29 and gas fitting and all work and materials kindred thereto, (2) the
30 steam and hot water heating and ventilating apparatus, steam power
31 plants and all work and materials kindred thereto, (3) the electrical
32 work, (4) structural steel and miscellaneous iron work and
33 materials, and (5) all general construction, which shall include all
34 other work and materials required to complete the building.

35 Commencing in the fifth year after the year in which P.L.2007,
36 c.137 (C.52:18A-235 et al.) takes effect, and every five years
37 thereafter, the Governor, in consultation with the Department of the
38 Treasury, shall adjust the amount set forth in this subsection or the
39 amount resulting from any adjustment under this subsection in
40 direct proportion to the rise or fall of the index rate as defined in
41 this subsection, and shall round the adjustment to the nearest
42 \$1,000. The Governor shall, no later than June 1 of every fifth
43 year, notify the development authority of the adjustment. The
44 adjustment shall become effective on July 1 of the year in which it
45 is made.

46 For the purposes of this subsection, "index rate" means the rate
47 of annual percentage increase, rounded to the nearest half-percent,
48 in the Implicit Price Deflator for State and Local Government

1 Purchases of Goods and Services, computed and published quarterly
2 by the United States Department of Commerce, Bureau of
3 Economic Analysis.

4 b. The development authority shall advertise and receive (1)
5 separate bids for each of the branches of work specified in
6 subsection a. of this section; or (2) bids for all the work and
7 materials required to complete the school facilities project to be
8 included in a single overall contract, in which case there shall be set
9 forth in the bid the name or names of all subcontractors to whom
10 the bidder will subcontract for the furnishing of any of the work and
11 materials specified in branches (1) through (4) in subsection a. of
12 this section; or (3) both.

13 c. Contracts shall be awarded as follows: (1) if bids are received
14 in accordance with paragraph (1) of subsection b. of this section,
15 the development authority shall determine the responsible bidder
16 for each branch whose bid, conforming to the invitation for bids,
17 will be most advantageous to the development authority, price and
18 other factors considered; (2) if bids are received in accordance with
19 paragraph (2) of subsection b. of this section, the development
20 authority shall determine the responsible bidder for the single
21 overall contract whose bid, conforming to the invitation for bids,
22 will be the most advantageous to the development authority, price
23 and other factors considered; or (3) if bids are received in
24 accordance with paragraph (3) of subsection b. of this section, the
25 development authority shall award separate contracts for each
26 branch of work specified in subsection a. of this section if the sum
27 total of the amounts bid by the responsible bidders for each branch,
28 as determined pursuant to paragraph (1) of this subsection, is less
29 than the amount bid by the responsible bidder for all of the work
30 and materials, as determined pursuant to paragraph (2) of this
31 subsection; but if the sum total of the amounts bid by the
32 responsible bidder for each branch, as determined pursuant to
33 paragraph (1) of this subsection is not less than the amount bid by
34 the responsible bidder for all of the work and materials, as
35 determined pursuant to paragraph (2) of this subsection, the
36 development authority shall award a single over-all contract to the
37 responsible bidder for all of the work and materials as determined
38 pursuant to paragraph (2) of this subsection.

39 d. For the purposes of this section, "other factors" means the
40 evaluation by the development authority of the ability of the single
41 contractor or the abilities of the multiple contractors to complete the
42 contract in accordance with its requirements and includes
43 requirements relating to the experience and qualifications of the
44 contractor or contractors and their key personnel in projects of
45 similar type and complexity; the performance of the contractor or
46 contractors on prior contracts with the development authority, the
47 State, or districts; the experience and capability of the contractor or
48 contractors and their key personnel in respect to any special

1 technologies, techniques or expertise that the project may require;
2 the contractor's understanding of the means and methods needed to
3 complete the project on time and within budget; the timetable to
4 complete the project; the contractor's plan for quality assurance and
5 control; the contractor's demonstrated experience in regard to
6 affirmative action; and other similar types of factors. The "other
7 factors" to be considered in evaluating bids and the weights
8 assigned to price and these "other factors" shall be determined by
9 the development authority prior to the advertisement for bids for
10 school facilities projects. In its evaluation of bids, the consideration
11 given to price by the development authority shall be at least equal to
12 the consideration given to the combination of all "other factors."

13 e. The development authority shall require from all contractors
14 to which it awards contracts pursuant to P.L.2000, c.72 (C.18A:7G-
15 1 et al.) and P.L.2007, c.137 (C.52:18A-235 et al.), the delivery of a
16 payment and performance bond issued in accordance with
17 N.J.S.2A:44-143 et seq.

18 f. The development authority shall adopt regulations to
19 implement this section which shall include, but not be limited to,
20 the procedural requirements for: (1) the evaluation and weighting of
21 price and "other factors" in the awarding of contracts; and (2) the
22 appealing of a prequalification classification and rating, a bid
23 rejection, and a contract award recommendation.

24 The rules and regulations promulgated by the New Jersey
25 Schools Construction Corporation pursuant to the provisions of
26 P.L.2000, c.72 (C.18A:7G-1 et al.) shall remain in full force and
27 effect unless subsequently revised by the development authority
28 following the enactment of P.L.2007, c.137 (C.52:18A-235 et al.).

29 g. Each evaluation committee selected by the development
30 authority to review and evaluate bids shall, at a minimum, contain a
31 representative from the district in which the school facilities project
32 is located if the district elects to participate.

33 h. All advertisements for bids shall be published in a legal
34 newspaper and be posted on the development authority's website
35 sufficiently in advance of the date fixed for receiving the bids to
36 promote competitive bidding but in no event less than 10 days prior
37 to such date. The advertisement for bids for construction projects
38 projected to cost in excess of \$500,000 shall include the
39 development authority's projected cost estimate ranges for the base
40 bid contract and any specified alternate proposal, such estimate
41 ranges having been attested to as reasonable by the individual or
42 firm preparing the cost estimate ranges. The highest amount of a
43 cost estimate range shall not be greater than five percent more than
44 the lowest amount. The projected cost estimate ranges shall be
45 attested no more than 30 days prior to the bid advertisement date.
46 Notice of revisions or addenda to advertisements or bid documents
47 relating to bids shall be advertised on the development authority's
48 website to best give notice to bidders no later than seven days,

1 Saturdays, Sundays and holidays excepted, prior to the bid due date.
2 The notice shall be provided to any person who has submitted a bid,
3 in one of the following ways: (a) in writing by certified mail or (b)
4 by certified facsimile transmission, meaning that the sender's
5 facsimile machine produces a receipt showing date and time of
6 transmission and that the transmission was successful or (c) by a
7 delivery service that provides certification of delivery to the sender.
8 Failure to advertise or provide proper notification of revisions or
9 addenda to advertisements or bid documents related to bids as
10 prescribed by this section shall prevent the acceptance of bids and
11 require the readvertisement for bids. Failure to obtain a receipt
12 when good faith notice is sent or delivered to the address or
13 telephone facsimile number on file with the development authority
14 shall not be considered failure by the development authority to
15 provide notice.

16 For purposes of this subsection:

17 "Specified alternate proposal" means a requirement of the bid
18 specification for bidders to submit prices for reduced, modified, or
19 supplemental work in addition to the base proposal which may
20 include, but not be limited to, a change in project scope or the use
21 of alternative materials or methods of construction.

22 i. Any purchase, contract, or agreement may be made,
23 negotiated, or awarded by the development authority without public
24 bid or advertising when the public exigency so requires.

25 j. Any purchase, contract, or agreement may be made,
26 negotiated, or awarded by the development authority without public
27 bid or advertising when the authority has advertised for bids on two
28 occasions and has received no bids on both occasions in response to
29 its advertisements. Any purchase, contract, or agreement may be
30 negotiated by the development authority after public bid or
31 advertising when the authority receives only a single responsive
32 bid, provided however that negotiation with that single responsive
33 bidder shall be limited to price.

34 k. The development authority may reject all bids for a
35 construction project only for any of the following publicly stated
36 bona fide reasons:

37 (1) The lowest bid substantially exceeds the published and
38 attested cost estimates or estimate ranges for the construction
39 project;

40 (2) The lowest bid substantially exceeds the appropriation, if
41 any, for the construction project;

42 (3) The development authority decides to abandon the
43 construction project; and

44 (4) The development authority wants to substantially revise the
45 scope and specifications for the construction project.

1 14. Section 7 of P.L.1954, c.48 (C.52:34-12) is amended to read
2 as follows:

3 7. a. Whenever advertising is required: (a) specifications and
4 invitations for bids shall permit such full and free competition as is
5 consistent with the procurement of supplies and services necessary
6 to meet the requirements of the using agency and shall, wherever
7 practicable, include such factors as life-cycle costs, sliding
8 percentage preference scales, or other similar analysis as shall be
9 deemed effective by the Director of the Division of Purchase and
10 Property, hereinafter referred to as the director, (b) the
11 advertisement for bids shall be in such newspaper or newspapers
12 and other medium or media selected by the State Treasurer as will
13 best give notice thereof to bidders and shall be sufficiently in
14 advance of the purchase or contract to promote competitive bidding;
15 (c) the advertisement shall designate the time and secure location
16 when and where proposals, which may be submitted in electronic or
17 other format designated by the director, shall be received, opened
18 and publicly announced, the amount of the cash or certified check,
19 if any, which must accompany each bid, and such other terms as the
20 State Treasurer may deem proper; (d) notice of revisions or addenda
21 to advertisements or bid documents relating to bids shall be
22 published in a newspaper or newspapers and other medium or
23 media selected by the State Treasurer to give notice to bidders at
24 least seven days, Saturdays, Sundays and holidays excepted, prior
25 to the bid due date; (e) failure to advertise for the receipt of bids or
26 to provide proper notification of revisions or addenda to
27 advertisements or bid documents related to bids as prescribed by
28 subsection (d) of this section shall prevent the acceptance of bids
29 and require the readvertisement for bids; (f) for any procurement,
30 the State Treasurer or the director may negotiate with bidders the
31 final terms and conditions of any procurement, including price;
32 such ability to so negotiate must be expressly set forth in the
33 applicable invitation to bid and such bids shall not be publicly
34 accessible until after negotiations have been completed and the
35 notice of intent to award the contract has been issued; (g) award
36 shall be made with reasonable promptness, after negotiation with
37 bidders where authorized, by written or electronic notice to that
38 responsible bidder whose bid, conforming to the invitation for bids,
39 will be most advantageous to the State, price and other factors
40 considered; **【and】** (h) the Treasurer shall require, with respect to
41 contracts for information technology goods and services, a
42 limitation of liability determined by the Director of the Division of
43 Purchase and Property; and (i) the advertisement for bids for
44 construction projects projected to cost in excess of \$500,000 shall
45 include the projected cost estimate ranges for the base bid contract
46 and any specified alternate proposal, such estimate ranges having
47 been attested to as reasonable by the individual or firm preparing
48 the estimate ranges; the highest amount of such cost estimate range

1 shall not be greater than five percent more than the lowest amount;
2 such projected cost estimate ranges shall be attested no more than
3 30 days prior to the bid advertisement date.

4 When negotiations occur pursuant to subparagraph **[f.]** (f) of this
5 **[section]** subsection, a written record of the nature and content of
6 the negotiations, as well as the dates and persons involved, shall
7 become a public record when the notice of intent to award the
8 contract is issued.

9 Any or all bids may be rejected when the State Treasurer or the
10 Director of the Division of Purchase and Property determines that it
11 is in the public interest so to do except that bids for construction
12 projects shall be rejected pursuant to the provisions of section 15 of
13 P.L. , c. (C.) (pending before the Legislature as this bill).
14 The State Treasurer or designee may adopt, pursuant to the
15 "Administrative Procedure Act," P.L.1968, c.410 (C.52:14B-1 et
16 seq.), such rules and regulations as may be necessary to implement
17 the provisions of this section.

18 This section shall apply to all bids received on and after the date
19 of enactment of P.L.1999, c.440.

20 For purposes of this subsection:

21 "Specified alternate proposal" means a requirement of the bid
22 specification for bidders to submit prices for reduced, modified, or
23 supplemental work in addition to the base proposal which may
24 include, but not be limited to, a change in project scope or the use
25 of alternative materials or methods of construction.

26 b. Whenever by law a State independent authority may negotiate
27 with bidders, after bid opening, the final terms and conditions of
28 any procurement, including price, and such ability to so negotiate is
29 expressly set forth in the applicable invitation to bid, a written
30 record of the nature and content of the negotiations, as well as the
31 dates and persons involved, shall not be publicly accessible until
32 after the notice of intent to award the contract is issued.

35 15. (New section) Bids received for construction projects, the
36 cost or contract price whereof is to be paid with or out of State
37 funds, except as otherwise provided, may all be rejected only for
38 any of the following publicly stated bona fide reasons:

39 a. The lowest bid substantially exceeds the published and
40 attested cost estimates or estimate ranges for the goods or services;

41 b. The lowest bid substantially exceeds the appropriation, if any,
42 for the goods or services;

43 c. A decision is made to abandon the construction project; and

44 d. The scope and specifications for the construction project are
45 substantially revised.
