Establishes animal cruelty offense of cruel confinement of a gestating pig.

AN ACT concerning cruel confinement of gestating sows, and 1 2 amending and supplementing Title 4 of the Revised Statutes. 3 4 **BE IT ENACTED** by the Senate and General Assembly of the State 5 of New Jersey: 6 7 1. (New section) a. For the purposes of this section: 8 "Crate" means to enclose, or restrict the movement of, a 9 gestating sow by using a box, cage, crate, enclosure, or enclosing 10 device, including devices commonly referred to as gestation crates; 11 or the box, cage, crate, enclosure, or other enclosing device, 12 including a gestation crate, that is used to enclose, or restrict the 13 movement of, a gestating sow. "Farm" means the land and the buildings, support facilities, and 14 equipment thereon, that are wholly or partially used for the 15 commercial production of animals or animal products used for food, 16 fiber, or other goods and services. "Farm" shall not include live 17 18 animal markets at which live animals are bought and sold in the 19 absence of any breeding operations. 20 "Farrowing crate" means an enclosure or enclosing device 21 commonly used with gestating sows to protect piglets from injury 22 during the birthing process and afterwards while nursing. "Fully extend its limbs" means to lift, stretch, or otherwise move 23 24 the legs or tail of an animal by the animal, to the fullest extent possible for the animal, without impediment and touching the side 25 26 or wall of a crate. "Gestating sow" means a pregnant domesticated pig that is kept 27 28 on a farm for breeding. 29 "Owner or operator" means the person who owns a farm or 30 controls the operations of a farm in a management capacity, but 31 shall not include a non-management employee or a contractor or 32 consultant. 33 "Person" means any individual, firm, partnership, joint venture, 34 association, limited liability company, corporation, estate, trust, 35 receiver or syndicate. 36 "Turn around freely" means to be able to turn in a complete circle without any impediment, including a tether, and without 37 38 touching the side or wall of a crate. 39 b. Notwithstanding the provisions of section 1 of P.L.1995, 40 c.311 (C.4:22-16.1), or any rules, regulations or standards adopted 41 pursuant thereto, to the contrary and except for the use of farrowing 42 crates as provided in subsection g. of this section, a person who, as 43 the owner or operator of a farm, personally and directly, or 44 indirectly through directions or instructions given to a contractor, 45 consultant or employee of the owner or operator of the farm, crates,

1 confines, or tethers a gestating sow kept on the farm in a manner 2 that prevents the animal from being able to turn around freely, lie 3 down, stand up, or fully extend its limbs shall be guilty of the 4 offense of cruel confinement of a gestating sow. No contractor, 5 consultant or employee of the owner or operator or the farm shall be 6 guilty of the offense of cruel confinement of a gestating sow.

c. Cruel confinement of a gestating sow is a disorderly persons
offense. Any person found guilty of this offense, in addition to any
other penalties applicable pursuant to Title 2C of the New Jersey
Statutes, shall be subject to a fine of not less than \$250 nor more
than \$1,000 for each offense, or imprisonment for a term of not
more than six months, or both. Each gestating sow that is subjected
to cruel confinement shall constitute a separate and distinct offense.

d. Cruel confinement of a gestating sow shall not includeconfinement for:

17 (2) veterinary examination, testing, individual treatment, an18 operation, or other veterinary procedures;

(3) transportation of the animal;

(4) an exhibition or educational program, including, but not
necessarily limited to, a 4-H program, county or State fair, or rodeo;
(5) animal husbandry purposes, provided the confinement is
temporary and for no more than eight hours in any 24-hour period;

(6) humane slaughtering of the animal in accordance with all
applicable laws, and rules and regulations adopted pursuant thereto,
concerning the slaughter of animals; and

(7) proper care of the gestating sow during the 10-day periodprior to the expected date of the gestating sow giving birth.

e. Nothing in this section may be construed to supersede or
limit the applicability of any other local, federal, or State law, rule,
or regulation protecting animal welfare, or to prevent any governing
body of a county or municipality from adopting or enacting any
ordinances, resolutions, rules or regulations concerning the
protection and welfare of animals that are more stringent than State
or federal law.

f. It is not an affirmative defense to an alleged violation of this
section that the gestating sow is domestic livestock, or was kept as
part of an agricultural operation or in accordance with customary
animal husbandry or farming practices.

g. The use of a farrowing crate is exempt from the provisions
of this section, and shall not be construed to be a violation of
subsection b. of this section.

46 a. (1) Overdrive, overload, drive when overloaded,

3 (2) Torment, torture, maim, hang, poison, unnecessarily or 4 cruelly beat, cruelly abuse, or needlessly mutilate a living animal or 5 creature, or cause or procure, by any direct or indirect means, 6 including but not limited to through the use of another living animal 7 or creature, any such acts to be done;

8 (3) Cause the death of, or serious bodily injury to, a living 9 animal or creature from commission of any act described in 10 paragraph (2), (4), or (5) of this subsection, by any direct or indirect 11 means, including but not limited to through the use of another living 12 animal or creature, or otherwise cause or procure any such acts to 13 be done;

14 (4) Fail, as the owner or a person otherwise charged with the 15 care of a living animal or creature, to provide the living animal or 16 creature with necessary care, or otherwise cause or procure such an 17 act to be done; or

18 (5) Cause bodily injury to a living animal or creature from 19 commission of the act described in paragraph (4) of this subsection; 20

Inflict unnecessary cruelty upon a living animal or creature, 22 by any direct or indirect means, including but not limited to through 23 the use of another living animal or creature; or leave the living 24 animal or creature unattended in a vehicle under inhumane 25 conditions adverse to the health or welfare of the living animal or 26 creature;

27 d. Receive or offer for sale a horse that is suffering from abuse 28 or neglect, or which by reason of disability, disease, abuse or 29 lameness, or any other cause, could not be worked, ridden or 30 otherwise used for show, exhibition or recreational purposes, or 31 kept as a domestic pet without violating the provisions of article 2 32 of chapter 22 of Title 4 of the Revised Statutes;

33 e. Keep, use, be connected with or interested in the 34 management of, or receive money or other consideration for the 35 admission of a person to, a place kept or used for the purpose of fighting or baiting a living animal or creature; 36

37 f. Be present and witness, pay admission to, encourage, aid or 38 assist in an activity enumerated in subsection e. of this section;

39 g. Permit or suffer a place owned or controlled by [him] the 40 person to be used as provided in subsection e. of this section;

41 h. Carry, or cause to be carried, a living animal or creature in 42 or upon a vehicle or otherwise, in a cruel or inhumane manner;

43 i. Use a dog or dogs for the purpose of drawing or helping to 44 draw a vehicle for business purposes;

45 j. Impound or confine or cause to be impounded or confined in 46 a pound or other place a living animal or creature, and shall fail to

supply the living animal or creature during such confinement with a 1 2 sufficient quantity of good and wholesome food and water;

Willfully sell, or offer to sell, use, expose, or cause or permit to be sold or offered for sale, used or exposed, a horse or other 6 7 animal having the disease known as glanders or farcy, or other 8 contagious or infectious disease dangerous to the health or life of 9 human beings or animals, or who shall, when any such disease is 10 beyond recovery, refuse, upon demand, to deprive the animal of 11 life:

24 Keep or exhibit a wild animal at a roadside stand or market n. 25 located along a public street or highway of this State; a gasoline 26 station; or a shopping mall, or a part of the premises thereof;

27 o. Sell, offer for sale, barter or give away or display live baby 28 chicks, ducklings or other fowl or rabbits, turtles or chameleons 29 which have been dyed or artificially colored or otherwise treated so 30 as to impart to them an artificial color;

Use any animal, reptile, or fowl for the purpose of soliciting 32 any alms, collections, contributions, subscriptions, donations, or 33 payment of money except in connection with exhibitions, shows or 34 performances conducted in a bona fide manner by recognized 35 breeders' associations, 4-H clubs or other similar bona fide 36 organizations;

37 q. Sell or offer for sale, barter, or give away living rabbits, turtles, baby chicks, ducklings or other fowl under two months of 38 39 age, for use as household or domestic pets;

Sell, offer for sale, barter or give away living baby chicks, 41 ducklings or other fowl, or rabbits, turtles or chameleons under two 42 months of age for any purpose not prohibited by subsection q. of 43 this section and who shall fail to provide proper facilities for the 44 care of such animals;

This act shall take effect on December 31, 2018. 1 2 3 4 **STATEMENT** 5 This bill establishes the animal cruelty offense of cruel 6 7 confinement of a gestating sow as a disorderly persons offense. 8 The bill defines cruel confinement of a gestating sow as crating, 9 confining, or tethering a gestating sow kept on the farm in a manner 10 that prevents the gestating sow from being able to turn around 11 freely (as defined in the bill), lie down, stand up, or fully extend its 12 limbs (as also defined in the bill). The bill exempts the use of 13 farrowing crates as an animal cruelty offense. Farrowing crates, as 14 defined in the bill, are enclosures or enclosing devices commonly 15 used with gestating sows to protect piglets from injury during the 16 birthing process and afterwards while nursing. 17 The bill specifies that an owner or operator of a farm may 18 commit this offense, personally and directly, or indirectly through 19 directions or instructions to a contractor, consultant or employee of 20 the owner or operator or the farm, but that a contractor, consultant, 21 or employee, whether following such directions or instructions or 22 not, would not be guilty of the offense. In addition to any other 23 penalties applicable pursuant to Title 2C of the New Jersey Statutes, 24 the bill provides that a violator would be fined for each offense not 25 less than \$250 nor more than \$1,000, or be imprisoned for a term of 26 not more than six months, or both, and that each gestating sow that 27 is cruelly confined would be a separate and distinct offense. 28 The bill exempts from consideration as cruel confinement of a 29 gestating sow, confinement for the purposes of: 30 1) medical research; 31 2) veterinary examinations, testing, individual treatment, or an 32 operation, or other veterinary procedures; 33 3) transportation of the animal; 34 4) an exhibition or educational program, including, but not 35 necessarily limited to, a 4-H program, county or State fair, or rodeo; 36 5) animal husbandry, provided the confinement is temporary 37 and for no more than eight hours in any 24-hour period; 38 6) humane slaughtering of the animal in accordance with 39 applicable laws, rules, and regulations concerning the slaughter of 40 animals; and 41 7) proper care of the animal during the 10-day period prior to 42 the expected date of the animal giving birth. 43 Finally, the bill specifies that: 44 1) none of the bill's provisions supersede other laws, rules or 45 regulations protecting animal welfare, or abridge the authority of 46 any county or municipality to adopt or enact ordinances, 47 resolutions, rules or regulations that are more stringent than State or 48 federal laws; and

1 2) it is not an affirmative defense to an alleged violation of this

2 bill that the gestating sow is domestic livestock, or was kept as part

3 of an agricultural operation or in accordance with customary animal

4 husbandry or farming practices.
