21 the Commissioner of Education shall provide State aid to each school
22 district in an amount equal to **[\$75]** \$150 multiplied by the number of

24 on or before November 5 for security services, equipment, or
25 technology to ensure a safe and secure school environment for
26 nonpublic school students.
