Opposes sale of Westminster Choir College to Chinese government-owned company Beijing Kaiwen Education Technology.

1 A CONCURRENT RESOLUTION opposing the sale of Westminster 2 Choir College to Beijing Kaiwen Education Technology. 3 4 WHEREAS, Believing that a choir of volunteer singers could be trained 5 to perform on a professional level, John Finley Williamson 6 established the Westminster Choir in 1920 at the Westminster 7 Presbyterian Church in Dayton, Ohio; and WHEREAS, In 1929, the Westminster Choir College was established at 8 9 Ithaca College, and three years later in 1932 the choir college 10 relocated to Princeton, New Jersey; and 11 WHEREAS, For nearly 100 years, Westminster Choir College has been 12 one of the nation's premier academic institutions for advanced musical studies, preparing men and women for careers as 13 14 performers and as music leaders in schools, universities, churches, 15 and professional and community organizations; and 16 WHEREAS, Over the years the small college struggled to remain 17 solvent, and in 1992 it merged with Rider University. The partnership continued for almost 26 years, until in 2016, Rider 18 19 University President Gregory Dell'Omo announced that Rider was 20 seeking to sell Westminster; and WHEREAS, On June 21, 2018, the Rider University Board of Trustees 21 22 announced that it had signed a purchase and sale agreement for the 23 transfer of the choir college to a Chinese company, Beijing Kaiwen 24 Education Technology (Kaiwen Education); and 25 WHEREAS, Prior to when it began operation in January 2018, Kaiwen 26 Education was known as Jiangsu Zhongtai Bridge Steel Structure 27 Company (Jiangsu). It has been alleged in a lawsuit brought to prevent the sale of Westminster that the steel company is a 28 29 manufacturer of components of Chinese naval vessels and is a 30 government-owned defense contractor for China's military; and WHEREAS, It has been speculated that Jiangsu changed its name to 31 Kaiwen Education to create the appearance that it is an educational 32 33 entity in order to justify its acquisition of the choir college; and 34 WHEREAS, Although often thought of as primarily a college town 35 because of its association with Princeton University, Princeton is 36 home to many world-renowned research centers in high technology, 37 defense, and cyber-space and is a center of studies for the United 38 States intelligence community; and 39 WHEREAS, Acclaimed and preeminent scientists and researchers in 40 various fields from around the world have chosen Princeton as a 41 place to live and work, a tradition famously highlighted by Albert 42 Einstein's decision to flee Nazi Germany for Princeton; and 43 WHEREAS, Given that Kaiwen Education, formerly a steel company, 44 does not have a history in higher education, particularly 45 professional music training, and with the multitude of world-class 46 scientists, researchers, and institutions located in Princeton, it appears that the Chinese government may be using the guise of 47 48 academia to infiltrate the choir college for nefarious purposes,

1 including the collection of United States intelligence and 2 intellectual property theft; and 3 WHEREAS, Nothing is more vital than the safety and security of the citizens of New Jersey and the nation, and it is essential that every 4 5 possible precaution is taken to ensure that a Chinese government-6 owned company does not exploit the openness of the world of 7 academia to establish a foothold in our open and free society for 8 illicit activities; now, therefore, 9 10 BE IT RESOLVED by the General Assembly of the State of New 11 Jersey (the Senate concurring): 12 13 1. The Legislature of the State of New Jersey opposes the sale 14 of Westminster Choir College by Rider University to Beijing 15 Kaiwen Education Technology because the proposed sale of the 16 choir college to a Chinese government-owned company could 17 jeopardize the security of United States citizens. 18 19 2. Copies of this resolution, as filed with the Secretary of State, 20 shall be transmitted by the Clerk of the General Assembly or the 21 Secretary of the Senate to the President of Rider University and to 22 each governing board member of Rider University. 23 24 25 **STATEMENT** 26 27 This concurrent resolution opposes the sale of Westminster Choir 28 College by Rider University to Beijing Kaiwen Education 29 Technology (Kaiwen Education) because the proposed sale of the 30 choir college to a Chinese government-owned company could 31 jeopardize the security of United States citizens. 32 On June 21, 2018, the Rider University Board of Trustees 33 announced that it had signed a purchase and sale agreement for the 34 transfer of the choir college to Kaiwen Education. Prior to when it 35 began operation in January 2018, Kaiwen Education was known as 36 Jiangsu Zhongtai Bridge Steel Structure Company, a government-37 owned Chinese defense contractor. The steel company's main forms 38 of business included the fabrication of large-scale bridge structures, 39 heavy steel sections of power plants, and construction of ship 40 blocks. Given that Kaiwen Education, formerly a steel company, 41 does not have a history in higher education, particularly 42 professional music training, and with the multitude of world-class 43 scientists, researchers, and institutions located in Princeton, it 44 appears that the Chinese government may be using the guise of 45 academia to infiltrate the choir college for nefarious purposes, 46 including the collection of United States intelligence and 47 intellectual property theft.
