1 AN ACT establishing the “New Jersey Complete Count
 2 Commission.”

3
 4 **BE IT ENACTED** *by the Senate and General Assembly of the State*
 5 *of New Jersey:*

6
 7 1. This act shall be known and may be cited as the “New Jersey
 8 Complete Count Commission Act.”

9
 10 2. a. There is created in, but not of, the Department of State,
 11 the “New Jersey Complete Count Commission.”

12 b. The commission shall consist of ¹~~21~~ ²~~25~~¹ 27² members
 13 as follows:

14 (1) the President of the Senate, or a designee;

15 (2) the Speaker of the General Assembly, or a designee;

16 (3) the Minority Leader of the Senate, or a designee;

17 (4) the Minority Leader of the General Assembly, or a designee;

18 (5) ¹two members of the New Jersey Legislative Latino Caucus,
 19 one of whom shall be a member of the Senate and one of whom
 20 shall be a member of the General Assembly, to be appointed ²by
 21 the President of the Senate and the Speaker of the General
 22 Assembly, respectively,² at the recommendation of the caucus
 23 chairperson;

24 (6) two members of the New Jersey Legislative Black Caucus,
 25 one of whom shall be a member of the Senate and one of whom
 26 shall be a member of the General Assembly, to be appointed ²by
 27 the President of the Senate and the Speaker of the General
 28 Assembly, respectively,² at the recommendation of the caucus
 29 chairperson;

30 (⁷)¹ the Governor, or a designee;

31 ¹~~[(6)]~~ (⁸)¹ the Secretary of State, or a designee;

32 ¹~~[(7)]~~ (⁹)¹ the Commissioner of the Department of Labor and
 33 Workforce Development, or a designee;

34 ¹~~[(8)]~~ (¹⁰)¹ three individuals representing municipalities in this
 35 State, reflecting the geographic diversity of the State, appointed by
 36 the Secretary of State;

EXPLANATION – Matter enclosed in bold-faced brackets **[thus]** in the above bill is

1 ¹[(9)] (11)¹ four individuals representing counties in this State,
2 reflecting the geographic diversity of the State, appointed by the
3 Governor;

4 ¹[(10)](12)¹ one representative each from four different
5 organizations representing the interests of minorities in the State,
6 appointed by the Secretary of State; ²[and]²

7 ¹[(11)] (13)¹ one representative each from three different
8 organizations representing the interests of business in the State,
9 including one organization representing minority business interests,
10 appointed by the Governor ²; and

11 (14) two individuals representing community-based,
12 philanthropic, non-profit, educational, civic, and faith-based
13 organizations, appointed by the Secretary of State².

14 ³c. No more than 14 of the members appointed to the
15 commission shall be of the same political party, as determined by
16 the member's political party affiliation during the one year
17 preceding the member's appointment to the commission.³

18
19 3. All appointments to the commission shall be made within 30
20 days after the date of enactment of this act, P.L. , c. (pending
21 before the Legislature as this bill). Vacancies in the membership of
22 the commission shall be filled in the same manner as the original
23 appointments were made. Members of the commission shall serve
24 without compensation but shall be entitled to reimbursement for
25 their actual and necessary expenses incurred in the performance of
26 their duties, within the limits of funds appropriated or otherwise
27 made available to the commission for its purposes.

29 4. The commission shall organize within 30 days after the
30 appointment of its members. The Secretary of State shall serve as
31 chairperson of the commission. The commission shall select a vice
32 chairperson from among its members. The commission may also
33 appoint a secretary, a director, and an assistant director, who need
34 not be a member of the commission. The director and assistant
35 director may be compensated from funds made available to the
36 commission for this purpose. The commission shall meet at the call
37 of the chairperson, or upon the request of any ¹[(10)] ²[(13)] 14²
38 members of the commission, who shall constitute a quorum.

40 5. The Department of State shall provide the staff services
41 necessary to support the functions of the commission. The
42 commission shall be entitled to call to its assistance and avail itself
43 of the services of the employees of any other State department,
44 board, bureau, commission or agency, as it may require and as may
45 be available to it for its purposes.

6. It shall be the duty of the commission to develop, recommend, and assist in the administration of a census outreach strategy to encourage full participation in the 2020 federal decennial census of population required by Section 141 of Title 13 of the United States Code. The census outreach strategy shall ²be designed to ensure an accurate and complete count of New Jersey's population and shall² include, but not be limited to, ²the following:

a. ² State agency initiatives to encourage participation in the 2020 Census ²[,] ;

b. ² the establishment and support of school-based outreach programs ²[,] ;

c. ² partnerships with non-profit community-based organizations ²[, and] ;

d. ² a multi-lingual ²[,] and multi-cultural² multi-media campaign ²[designed to ensure an accurate and complete count of New Jersey's population] with information that may be widely disseminated through print, audio, television, the Internet, and social media in this State among all of its diverse populations and communities on the importance of completing the 2020 Census survey and the resources available to do so;

e. at least three public hearings, one each in the Northern, Central, and Southern portions of the State, to receive testimony from the public, elected officials, experts, and others on ways to ensure a full 2020 Census count of the population in this State; and

f. ensuring that hard-to-count populations, such as African Americans, Hispanics or Latinos, Asian Americans, non-native English speakers, persons who are indigent, persons who are homeless, college students, children under five years of age, men ages 18-49, the elderly, persons displaced by natural disasters, persons who are incarcerated, and members of the LGBTQ community are counted, and that immigrant populations in this State understand the confidentiality of the census survey and the importance of completing the 2020 Census regardless of citizenship status².

To assist in carrying out its duties, the commission may create and appoint subcommittees as it deems appropriate and shall solicit participation from relevant experts and practitioners involved in census issues.

7. The outreach strategy of the New Jersey Complete Count Commission shall be coordinated through the Office of the Secretary of State, which shall provide administrative support to the commission and coordinate with all State agencies and constitutional officers, as well as units of local government, to identify effective methods of outreach to New Jersey's population and to provide resources to ensure the outreach program is successful and that all New Jersey residents are counted. All State agencies shall inform the Office of the Secretary of State of their

1 designated census coordinator and cooperate with the commission
2 and provide support to the commission. For the purposes of this
3 section, “State agencies” means any executive agency or
4 department directly responsible to the Governor. Other entities of
5 government, including other constitutional officers, the offices of
6 the legislative and judicial branches, and units of local government
7 shall cooperate and provide all reasonable assistance to the
8 commission.

9
10 8. The commission shall submit an interim report to the
11 Governor, and to the Legislature pursuant to section 2 of P.L.1991,
12 c.164 (C.52:14-19.1), within six months of its organizational
13 meeting, containing its recommended outreach strategy to
14 encourage full participation and to avoid an undercount in the 2020
15 Census. Thereafter, the commission shall submit its final report to
16 the Governor and to the Legislature no later than June 30, 2019,
17 specifying its recommended outreach strategy for implementation
18 for the 2020 Census. The commission shall expire on January 1,
19 2020.

21 9. This act shall take effect immediately, and shall expire on
22 January 1, 2020.
