AN ACT concerning computer science education and supplementing
chapter 26 of Title 18A of the New Jersey Statutes.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

7 The State Board of Education shall authorize a 1. a. computer science education endorsement to the instructional 8 certificate. The endorsement shall authorize the holder to teach 9 computer science in all public schools, and shall be required to 10 teach computer science in grades 9 through 12 beginning at such 11 12 time as the State board determines that there is a sufficient number 13 of teachers holding the computer science education endorsement to 14 make the requirement feasible.

b. The standards established by the State board shall require a candidate for the endorsement to hold ¹[a standard] <u>an</u>¹ instructional certificate with at least one other teaching endorsement and provide documentation that the candidate has completed the computer science related coursework requirements determined by the State board up to a maximum of 15 credits.

³[A teacher who taught computer science within the three 21 c. 22 years prior to such time as the State board determines to require a 23 computer science education endorsement to teach computer science in grades 9 through 12, shall be ²[issued a computer science 24 education endorsement to the instructional certificate upon 25 application to the State Board of Examiners] eligible to apply to the 26 27 State Board of Examiners for the issuance of a computer science endorsement to the instructional certificate upon a demonstration 28 that the teacher, through coursework, teaching experience, or a 29 combination of both, has met the knowledge and skill standards for 30 the computer science endorsement established by the State Board of 31 Education under subsection b. of this section²] A candidate who 32 33 can document proficient experience teaching computer science for 34 the equivalent of two school years within the last four years prior to such time as the State board determines to require a computer 35 36 science education endorsement to teach computer science in grades
