N.J.S.38A:3-6 is amended to read as follows: 8 38A:3-6. Under the direction of the Governor, the Adjutant 9 General shall: 10 (a) Exercise control over the affairs of the Department of 11 Military and Veterans' Affairs and in connection therewith make 12 and issue such regulations governing the work of the Department of Military and Veterans' Affairs and the conduct of its employees as 13 may, in his judgment, be necessary or desirable. 14 15 (b) Be the request officer of the Department of Military and Veterans' Affairs within the meaning of such term as defined in 16 17 section 1 of P.L.1944, c.112 (C.52:27B-1). 18 (c) (Deleted by amendment, P.L.1988, c.138.) 19 (d) Command the organized militia of the State, with responsibility for recruiting, mobilization, administration, training, 20 21 discipline, equipping, supply and general efficiency thereof. He 22 may issue such regulations and delegate such command functions as 23 he shall deem necessary. The regulations so issued shall, insofar as 24 possible, conform to the federal laws and regulations concerning the 25 same. 26 (e) Maintain the archives and be the custodian of the records 27 and papers required, by laws or regulations, to be filed with the Department of Military and Veterans' Affairs. 28 (f) Supervise, administer and coordinate those activities of the 29 30 selective service system for which the Governor is responsible. 31 (g) Acquire by gift, grant, purchase, exchange, eminent domain, 32 or in any other lawful manner, in the name of and for the use of the State of New Jersey, all those parcels of land as shall be necessary 33 34 for armories and other militia facilities, and supervise the design, construction, alteration, maintenance and repair of said property. 35 36 (h) Establish and maintain such headquarters as may be required 37 for the militia. (i) Exercise the powers vested in him and perform such other 38 39 duties and functions as required of him by the Governor and by 40 federal and State laws and regulations.

(j) Exercise all of the functions, powers and duties heretofore
 vested in the Director of the Division on Veterans' Programs and

4 (k) Appoint and remove officers and other personnel employed

6 and Title 11A of the New Jersey Statutes and other applicable
7 statutes, except as herein otherwise specifically provided.

8 (1) Have authority to organize and maintain an administrative 9 division and to assign to employment therein secretarial, clerical 10 and other assistants in the department or the Adjutant General's 11 Office for the purpose of providing centralized support to all 12 segments of the department, including budgeting, personnel 13 administration and oversight of equal opportunity programs.

(m) Perform, exercise and discharge the functions, powers and
duties of the department through such divisions as may be
established by this act or otherwise by law.

(n) Organize the work of the department in divisions not
inconsistent with the provisions of this act and in bureaus and other
organizational units as the Adjutant General may determine to be
necessary for efficient and effective operation.

(o) Adopt, issue and promulgate, in the name of the department,
pursuant to the "Administrative Procedure Act," P.L.1968, c.410
(C.52:14B-1 et seq.), such rules and regulations as may be
authorized by law.

(p) Institute, or cause to be instituted, legal proceedings or
processes as necessary to properly enforce and give effect to any of
the Adjutant General's powers or duties.

(q) Make an annual report to the Governor and to the
Legislature of the department's operations, and render other reports
as the Governor shall from time to time request or as may be
required by law.

32 (r) Coordinate the activities of the department, and the several
33 divisions and other agencies therein, in a manner designed to
34 eliminate overlapping and duplicative functions.

(s) Integrate within the department, so far as practicable, all
staff services of the department and of several divisions and other
agencies therein.

(t) Request access to all relevant files and records of other State
agencies, which may be made available to the Adjutant General by
the head of a State agency, and request, subject to the permission of
the head of the State agency, any officer or employee therein to
provide information as necessary to assist in the performance of the
functions of the department.

(u) Supervise and operate the New Jersey Veterans' Memorial
Home-Menlo Park, the New Jersey Veterans' Memorial HomeVineland, the New Jersey Veterans' Memorial Home-Paramus and
the New Jersey Veterans' Memorial Cemetery-Arneytown.

1 (v) Supervise and operate the liaison office and the field offices 2 which serve the federal Veterans' Affairs Medical Centers.

3 (w) Make application for federal grants and programs, other than4 education grants or funds.

5 (x) Administer the federally-funded training and rehabilitation 6 programs, except for the administration of federally-funded 7 education and training programs set forth in 38 U.S.C. s.36 et seq.

8 (y) Provide current information to the general public on State 9 and federal veterans' programs and benefits; create a comprehensive 10 public webpage for women veterans that includes, but is not limited 11 to, the following information: veterans' legal rights, benefits, 12 medical and insurance issues, education, the transition from active 13 service to civilian life, and other resources available to veterans.

(z) Develop and administer the New Jersey Homeless Veterans
Grant Program established pursuant to section 3 of P.L.2013, c.239
(C.38A:3-6.2b).

17 (aa) Encourage and facilitate the registration of each service 18 member residing in New Jersey with the United States Department 19 of Veterans Affairs, or its successor agency. Registration shall take 20 place, as appropriate, when the service member returns from 21 deployment on federal active duty or is discharged or as soon as 22 possible thereafter. The term "service member" shall mean 23 members of the New Jersey National Guard and members of the 24 United States Armed Forces, or a Reserve component thereof, when 25 the information on each member is made available to the 26 department.

27 (bb) Develop and coordinate a volunteer-based program comprised of former servicemembers to assist and mentor veterans 28 29 who become involved with the criminal justice system, while 30 criminal proceedings are pending and afterward, in accessing 31 assistance to resolve the underlying problems that led or contributed 32 to the veteran's involvement with the criminal justice system 33 including, but not limited to, offering support and guidance, 34 securing housing, employment linkages, job training, education, 35 transportation, disability compensation claims, discharge status, 36 health care and other linkages available at the local. State and 37 federal level that can ease the challenge of reentry into civilian life. 38 In addition, the Adjutant General shall develop a registry of 39 volunteer mentors and make the registry available pursuant to 40 P.L.2017, c.42 (C.2C:43-23 et al.).

41 (cc) Prepare and disseminate a directory of Veterans Diversion
42 Resource Program entities currently available within New Jersey
43 pursuant to P.L.2017, c.42 (C.2C:43-23 et al.).

(dd) Create a comprehensive public webpage for Gold Star
family members that includes, but is not limited to, the following
information: State benefits; State and county liaisons; a list of
service members from New Jersey killed in action; links to other
Gold Star family organizations; and such other information and

1 resources as the Adjutant General deems necessary and beneficial to 2 a Gold Star family member. A "Gold Star family member" means 3 the spouse, domestic partner, partner in a civil union, parent, 4 brother, sister, child, legal guardian, or other legal custodian, 5 whether of the whole or half blood, or by adoption. This act shall take effect immediately. 14 15 16 **STATEMENT** 17 18 This bill requires the Adjutant General to identify each New 19 Jersey resident who enrolls in the United States Military Academy, 20 United States Naval Academy, United States Coast Guard 21 Academy, United States Merchant Marine Academy, or United 22 States Air Force Academy, and issue a New Jersey State flag to that 23 individual. 24 This bill honors each resident of New Jersey who enrolls in a 25 federal service academy for that individual's commitment to the 26 defense of New Jersey and the United States of America.
