AN ACT concerning voluntary contributions through gross income 1 2 tax returns to support the Meals on Wheels program in New 3 Jersey, supplementing chapter 9 of Title 54A of the New Jersey 4 Statutes. 5 6 **BE IT ENACTED** by the Senate and General Assembly of the State 7 of New Jersey: 8 9 1. a. There is established in the Department of the Treasury a special fund to be known as the "Meals on Wheels in New Jersey 10 Fund." 11 12 b. A taxpayer shall have the opportunity to indicate on the 13 taxpayer's New Jersey gross income tax return that a portion of the 14 taxpayer's tax refund or an enclosed contribution shall be deposited 15 in the "Meals on Wheels in New Jersey Fund." Any costs incurred by the Division of Taxation for collection 16 c. 17 or administration attributable to this section may be deducted from 18 receipts collected pursuant to this section, as determined by the 19 Director of the Division of Budget and Accounting in the Department of the Treasury. The State Treasurer shall deposit net 20 contributions collected pursuant to this section into the "Meals on 21 22 Wheels in New Jersey Fund." 23 The Legislature shall annually appropriate all monies d. 24 deposited in the "Meals on Wheels in New Jersey Fund" established pursuant to this section for distribution to the Meals on Wheels 25 26 America organization for allocation to each of the independently-27 run local programs operating in the State of New Jersey to support 28 its programs enabling senior citizens to live healthier lives in their 29 own home. 30 31 2. This act shall take effect immediately and apply to taxable 32 years beginning on or after the January 1 next following enactment.
