Requires study of safety of school bus passengers in certain emergency situations, including school bus accidents; appropriates \$250,000.

BE IT ENACTED by the Senate and General Assembly of the State

7 The Commissioner of Education, in consultation with 1. a. 8 the Superintendent of the Division of State Police in the Department 9 of Law and Public Safety, the Director of the Division of Highway 10 Traffic Safety in the Department of Law and Public Safety, the 11 Chief Administrator of the New Jersey Motor Vehicle Commission, 12 and the Director of the Office of Homeland Security and Preparedness, shall study ²<u>or contract with a research institution to</u> 13 $\underline{\text{study}}^{2}$ $\frac{1}{2}$ the safety of school bus passengers involved in 14 emergency situations, including, but not limited to, school bus 15 16 accidents, such as head-on, rear-end, and side-impact collisions, and situations where the school bus may roll over $\frac{1}{3}$ safety technologies, 17 18 including, but not limited to, speed restrictors, automatic braking, electronic stability control, and event data recorders, that are 19 available in newly manufactured school buses or may be installed in 20 school buses after manufacture; and the qualifications for school 21 22 bus drivers, including, but not limited to, age, physical fitness requirements, and necessary experience¹. The study shall include 23 an evaluation of the statutory and regulatory requirements relating 24 to school bus safety ¹, the oversight of school bus operations, 25 including, but not limited to, maintenance of vehicles, school bus 26 drivers qualifications, and audits of school districts and 27 contractors,¹ and the current policies, plans, and procedures 28 29 implemented by school districts.

30 b. Within 120 days of the ²[effective date of this act] <u>completion of the study</u>², the commissioner 2 , in consultation with 31 the Superintendent of the Division of State Police, the Director of 32 33 the Division of Highway Traffic Safety, the Chief Administrator of 34 the New Jersey Motor Vehicle Commission, and the Director of the Office of Homeland Security and Preparedness,² shall prepare and 35 submit a report to the Governor and, pursuant to section 2 of 36 37 P.L.1991, c.164 (C.52:14-19.1), to the Legislature summarizing the 38 study's findings and making recommendations to improve the 39 safety of school bus passengers.

40 ²c. There is appropriated from the General Fund to the Department of Education the sum of \$250,000 to implement the 41 42 provisions of this act.²
