Requires State to use at least half of future federal “Help America Vote Act” funds for voting systems with paper record.

1 AN ACT concerning the use of certain federal fund allocations for  
2 election technology purposes and amending P.L.2004, c.88.

4 **BE IT ENACTED** by the Senate and General Assembly of the State  
5 of New Jersey:

7 1. Section 3 of P.L.2004, c.88 (C.19:61-3) is amended to read  
8 as follows:

9 3. There is hereby established in the Department of the  
10 Treasury a special, nonlapsing fund to be known as the Federal  
11 Elections Assistance Fund.

12 The fund is established in accordance with paragraph (b) of  
13 section 254 of Pub.L.107-252, (42 U.S.C.15404) for the purpose of  
14 receiving:

15 a. all moneys appropriated or otherwise made available by the  
16 State for the purpose of carrying out the activities required by  
17 Pub.L.107-252;

18 b. all payments which will be received from the federal  
19 government pursuant to Pub.L.107-252;

20 c. interest earned on deposits made in the fund; and

21 d. such other additional amounts as may be appropriated under  
22 federal or State law.

23 The State Treasurer is authorized to transfer into the fund in a  
24 timely manner such State moneys as will be necessary to insure that  
25 the State qualifies for the maximum amount of federal funds  
26 appropriated to implement Pub.L.107-252.

27 Notwithstanding the provisions of any other law, rule, or  
28 regulation to the contrary, at least half of federal funds appropriated  
29 to the State in accordance with Pub.L.107-252 during the 15 years  
30 following the effective date of P.L. , c. (pending before the  
31 Legislature as this bill) shall be allocated by the State Treasurer for  
32 the purpose of replacing voting machines with a voting system that  
33 provides a paper record of each vote cast.

38 STATEMENT

40 Under the federal "Help America Vote Act of 2002," Pub.L.107-  
41 252, also known as HAVA, the federal government allocated to the  
42 State funding for modernizing various aspects of the elections  
43 process. This bill provides that at least half of any future funds  
44 allocated to the State under HAVA during the 15 years following  
45 the bill's effective date would be used to replace current voting  
46 machines with a voting system that provides a paper record of each  
47 vote cast.
