A JOINT RESOLUTION designating the Lake Hopatcong Racing 1 2 Association as the New Jersey Governor's Cup Hydrofest Series 3 and amending P.L.2009, J.R.4. 4 5 WHEREAS, In 2009, the State designated the Sunset Lake Hydrofest as the New Jersey Governor's Cup Hydrofest Series; and 6 7 WHEREAS, In September 2015, the Hydrofest Planning Committee cancelled the Sunset Lake Hydrofest (renamed the Wildwoods 8 9 Hydrofest New Jersey Governor's Cup Regatta) because the 10 reconfiguration of the streets and parks along the Sunset Lake bay 11 area made it no longer feasible to hold the event there; and 12 WHEREAS, The Lake Hopatcong Racing Association features powerboat racing at its finest and draws a large crowd of people to 13 14 New Jersey to enjoy the event and benefit local businesses; now, 15 therefore, 16 17 BE IT RESOLVED by the Senate and General Assembly of the 18 State of New Jersey: 19 20 1. Section 1 of P.L.2009, J.R.4 (C.34:1A-52.1) is amended to 21 read as follows: 22 1. The [Sunset Lake Hydrofest in Wildwood Crest] Lake 23 Hopatcong Racing Association in Lake Hopatcong State Park, New 24 Jersey, is designated as the New Jersey Governor's Cup Hydrofest 25 Series. 26 (cf: P.L.2009, J.R.4, s.1) 27 28 2. Section 2 of P.L.2009, J.R.4 (C.34:1A-52.2) is amended to 29 read as follows: 30 2. An appropriate perpetual trophy or commendation, to be 31 provided by the governing body of the event, shall be designated as 32 the New Jersey Governor's Cup of the [Sunset Lake Hydrofest in Wildwood Crest, New Jersey] Lake Hopatcong Racing Association. 33 34 (cf: P.L.2009, J.R.4, s.2) 35 3. Section 3 of P.L.2009, J.R.4 (C.34:1A-52.3) is amended to 36 37 read as follows: 38 3. Every year, the Governor, or the designee thereof, shall 39 award the New Jersey Governor's Cup to the winner of the [Sunset Lake Hydrofest] Lake Hopatcong Racing Association. 40 (cf: P.L.2009, J.R.4, s.3) 41 42 43 4. This joint resolution shall take effect immediately.

STATEMENT

3 This joint resolution designates the Lake Hopatcong Racing Association in Lake Hopatcong State Park, New Jersey, as the New 4 5 Jersey Governor's Cup Hydrofest Series. In 2009, the State designated the Sunset Lake Hydrofest as the New Jersey Governor's 6 7 Cup Hydrofest Series. In September 2015, the Hydrofest Planning 8 Committee cancelled the Sunset Lake Hydrofest (renamed the Wildwoods Hydrofest New Jersey Governor's Cup Regatta) 9 because the reconfiguration of the streets and parks along the 10 Sunset Lake bay area made it no longer feasible to hold the event. 11 12 This joint resolution transfers the New Jersey Governor's Cup 13 Hydrofest Series from the Sunset Lake Hydrofest to the Lake 14 Hopatcong Racing Association.
