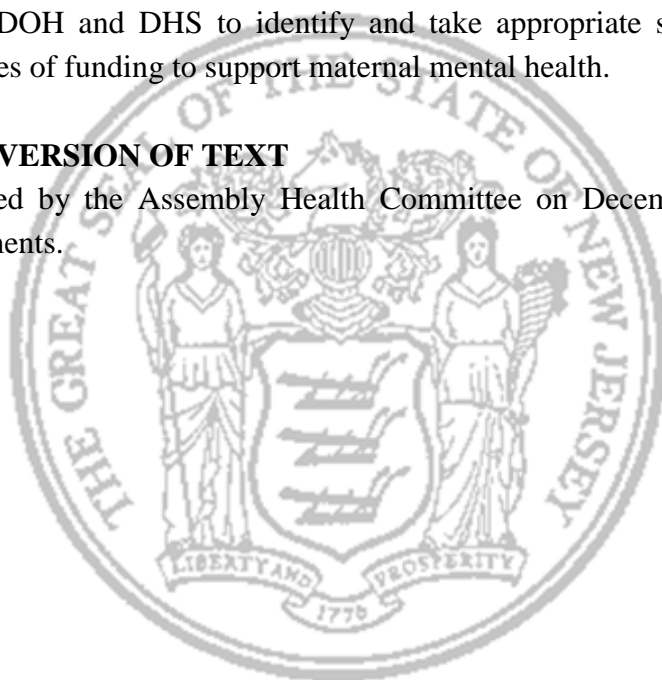

SYNOPSIS

Requires DOH and DHS to identify and take appropriate steps to secure federal sources of funding to support maternal mental health.

1 AN ACT concerning maternal mental health ¹**[and supplementing**
2 Title 26 and Title 30 of the Revised Statutes]¹.

4 **BE IT ENACTED** *by the Senate and General Assembly of the State*
5 *of New Jersey:*

7 1. a. The Department of Health shall identify and take
8 appropriate steps to secure federal sources of funding to support
9 maternal mental health in the State, including, but not limited to,
10 the grant available pursuant to section 10005 of the federal “21st
11 Century Cures Act,” Pub. L. 114-255, 42 U.S.C. s.247b-13a.

12 b. No later than ¹**[January 1, 2020]** September 1, 2021¹, the
13 department shall report to the Legislature, pursuant to section 2 of
14 P.L.1991, c.164 (C.52:14-19.1), concerning its efforts to secure and
15 utilize federal sources of funding to support maternal mental health
16 pursuant to subsection a. of this section.

18 2. a. The Department of Human Services shall identify and
19 take appropriate steps to secure federal sources of funding to
20 support maternal mental health in the State.

21 b. No later than ¹**[January 1, 2020]** September 1, 2021¹, the
22 department shall report to the Legislature, pursuant to section 2 of
23 P.L.1991, c.164 (C.52:14-19.1), concerning its efforts to secure and
24 utilize federal sources of funding to support maternal mental health
25 pursuant to subsection a. of this section.

27 3. This act shall take effect immediately and shall expire on
28 January 1, ¹**[2023]** 2024¹.
