SYNOPSIS

Establishes “5G Network and Development Task Force.”

1 AN ACT establishing the “5G Network and Development Task
2 Force.”

4 **BE IT ENACTED** by the Senate and General Assembly of the State
5 of New Jersey:

7 1. a. There is established, in the Department of Community
8 Affairs, a task force to be known as the “5G Network and
9 Development Task Force.”

10 b. The task force shall consist of five members as follows:

11 (1) the Commissioner of Community Affairs, or a designee;

12 (2) the President of the Board of Public Utilities, or a designee;

13 (3) one member who is a representative of the New Jersey State
14 League of Municipalities, appointed by the Governor;

15 (4) one public member appointed by the Governor upon the
16 recommendation of the President of the Senate; and

17 (5) one public member appointed by the Governor upon the
18 recommendation of the Speaker of the General Assembly.

19 c. The members of the task force shall be appointed within 60
20 days following the effective date of this section. The task force
21 shall organize as soon as practicable after the appointment of a
22 majority of its members. The Commissioner of Community Affairs,
23 or the commissioner’s designee, shall serve as chairperson of the
24 task force. The presence of three members of the task force shall
25 constitute a quorum. The task force may conduct business without
26 a quorum, but may only vote on the issuance of the report required
27 to be submitted to the Governor and the Legislature pursuant to
28 subsection g. of this section when a quorum is present. Vacancies
29 in the membership of the task force shall be filled in the same
30 manner as the original appointments.

31 d. All task force members shall serve without compensation,
32 but shall be eligible for reimbursement of necessary and reasonable
33 expenses incurred in the performance of their official duties within
34 the limits of funds appropriated or otherwise made available to the
35 task force for its purposes.

36 e. The Department of Community Affairs shall provide such
37 stenographic, clerical, and other administrative assistants, and such
38 professional staff, as the commission requires to carry out its work.
39 The task force shall also be entitled to call to its assistance and avail
40 itself of the services of the employees of any State, county, or
41 municipal department, board, bureau, commission, or agency as it
42 may require and as may be made available to it for its purposes.

43 f. The task force may meet and hold public hearings at the
44 place or places it designates during the sessions or recesses of the
45 Legislature.

46 g. The task force shall study State and federal law and develop
47 recommendations for State statutory changes necessary to ensure
48 that future development in the State accommodates, and does not

1 disrupt, “5th Generation” wireless networks, and shall, within one
2 year of the effective date of this section, prepare and submit a report
3 to the Governor and the Legislature, pursuant to section 2 of
4 P.L.1991, c.164 (C.52:14-19.1), setting forth the results of its
5 studies and its recommendations.

6 h. The task force shall expire upon the submission of its report.

8 2. This act shall take effect immediately.

STATEMENT

13 This bill establishes the “5G Network and Development Task
14 Force” to study and develop recommendations on how to harmonize
15 the approaching rollout of “5th Generation” (5G) wireless networks
16 and future development within the State. Before 5G networks begin
17 to be rolled out, the requirements for building in the State are going
18 to have to be updated in order to ensure that these networks are not
19 disrupted by future development. This task force would be charged
20 with laying critical groundwork in anticipation of the shift to 5G
21 network technology.

22 The task force would consist of five members as follows:

23 (1) the Commissioner of Community Affairs, or a designee;

24 (2) the President of the Board of Public Utilities, or a designee;

25 (3) one member who is a representative of the New Jersey State
26 League of Municipalities, appointed by the Governor;

27 (4) one public member appointed by the Governor upon the
28 recommendation of the President of the Senate; and

29 (5) one public member appointed by the Governor upon the
30 recommendation of the Speaker of the General Assembly.

31 The task force would have one year from the bill’s effective date
32 to submit a report to the Governor and the Legislature setting forth
33 the results of its studies and recommendations. The task force
34 would expire upon the submission of this report.
