1 AN ACT concerning racial and ethnic minorities and the coronavirus 2 disease 2019. 3 4 **BE IT ENACTED** by the Senate and General Assembly of the State 5 of New Jersey: 6 7 1. a. As used in this section: "Health care professional" means a person licensed to practice a 8 9 health care profession pursuant to Title 45 of the Revised Statutes. 10 b. The Department of Health shall establish the New Jersey 11 Racial Equity Rapid Response Team. The purpose of the New 12 Jersey Racial Equity Rapid Response Team shall be to: 13 (1) document the impact of severe acute respiratory syndrome 14 coronavirus 2 and the coronavirus disease 2019 pandemic on racial 15 and ethnic minorities; 16 (2) develop strategies based on data to slow the spread of severe 17 acute respiratory syndrome coronavirus 2 and the coronavirus 18 disease 2019 in racial and ethnic minorities; (3) develop strategies to improve the overall health of racial and 19 20 ethnic minorities; and 21 (4) identify three areas in the State with the most per capita deaths due to the coronavirus disease 2019 that consist of a 22 23 municipality or a group of municipalities that are situated within 24 close proximity to one another. 25 c. (1) The Department of Health shall establish three advisory 26 units to be assigned to each of the areas identified in paragraph (4) 27 of subsection b. of this section. d. Each advisory unit established pursuant to subsection c. of 28 29 this section shall consist of eight members as follows: the mayor of 30 a municipality to which the respective advisory unit is assigned, or 31 a designee, three residents of the municipality or municipalities to 32 which the respective advisory unit is assigned, two of which shall 33 be health care professionals, a municipal public health officer, a 34 county emergency management or public health officer, a 35 community advocate, and an educator. The purpose of each advisory unit established pursuant to 36 e. 37 subsection c. of this section shall be to: (1) promote public awareness and education regarding the 38 39 coronavirus disease 2019 pandemic; 40 (2) promote coronavirus disease 2019 prevention, testing, 41 treatment, and other support services, as determined by the 42 Department of Health; and (3) develop strategies to mitigate the harm caused by the 43 44 coronavirus disease 2019 pandemic in the area to which the 45 respective advisory unit is assigned and improve the economic 46 circumstance and health conditions of residents therein.

This act shall take effect immediately and shall expire upon
 the end of both the state of emergency and the public health
 emergency declared in response to the coronavirus disease 2019
 pandemic.

STATEMENT

9 This bill establishes the New Jersey Racial Equity Rapid 10 Response Team.

11 Under the bill, the Department of Health (DOH) is to establish 12 the New Jersey Racial Equity Rapid Response Team. The purpose 13 of the New Jersey Racial Equity Rapid Response Team is to: (1) document the impact of severe acute respiratory syndrome 14 15 coronavirus 2 and the coronavirus disease 2019 pandemic on racial 16 and ethnic minorities; (2) develop strategies based on data to slow 17 the spread of severe acute respiratory syndrome coronavirus 2 and 18 the coronavirus disease 2019 in racial and ethnic minorities; (3) 19 develop strategies to improve the overall health of racial and ethnic 20 minorities; and (4) identify three areas in the State with the most 21 per capita deaths due to the coronavirus disease 2019 that consist of 22 a municipality or a group of municipalities.

23 The bill provides that the DOH is to establish three advisory 24 units to be assigned to each of the areas identified as having the 25 most per capita deaths due to the coronavirus disease 2019. Each 26 advisory unit is to consist of eight members as follows: the mayor 27 of a municipality to which the respective advisory unit is assigned, 28 or a designee, three residents of the municipality or municipalities 29 to which the respective advisory unit is assigned, two of which shall 30 be health care professionals, a municipal public health officer, a 31 county emergency management or public health officer, a 32 community advocate, and an educator.

33 Under the bill, the purpose of each advisory unit is to: (1) 34 promote public awareness and education regarding the coronavirus 35 disease 2019 pandemic; (2) promote coronavirus disease 2019 36 prevention, testing, treatment, and other support services, as 37 determined by the DOH; and (3) develop strategies to mitigate the 38 harm caused by the coronavirus disease 2019 pandemic in the area 39 to which the respective advisory unit is assigned and improve the 40 economic circumstance and health conditions of residents therein.

41 It is the sponsor's belief that the persistence of deep racial 42 disparities and divisions across society is evidence of institutional 43 racism-the routine, often invisible and unintentional, production 44 of inequitable social opportunities and outcomes. When racial 45 equity is not consciously addressed, racial inequality is often 46 unconsciously replicated. A racial equity approach will advance the 47 fight against the coronavirus disease 2019 and any conditions or 48 diseases resulting from the coronavirus disease 2019. Ending the

threat requires targeting strategies and resources towards those who 1 2 are most impacted by this pandemic, those least able to shelter in 3 place, and those facing the worst health inequities. Instead of 4 blaming and stigmatizing those who are most at risk of contracting 5 coronavirus disease 2019, the sponsor believes that their needs must 6 be centered, and the disease should be attacked with the urgency the 7 moment demands. Structural racism has always been a pre-existing 8 condition. All of society benefits from ending the threat of the 9 virus by attacking structural racism.
