**BE IT ENACTED** by the Senate and General Assembly of the State of New Jersey:

8 1. When the Governor, President of the Senate, Speaker of the 9 General Assembly, or any other person is authorized by law to 10 appoint a member to a board, commission, task force, or any other 11 multi-member body or entity established by a statute enacted before, 12 on, or after the effective date of this act, P.L., c. (pending before the Legislature as this bill), the Governor, President, Speaker, or 13 14 other authorized person, as appropriate, shall make the goal of 15 attaining a membership for such a board, commission, task force, or 16 multi-member body or entity that reflects the racial and gender 17 diversity of the residents of the State a primary consideration when 18 selecting a person for appointment on or after that effective date. The goal of attaining a membership that reflects the racial and gender 19 20 diversity of the residents of the State shall be a primary consideration 21 by the appointing authority unless that consideration conflicts with 22 the particular circumstances of the appointment to be made or 23 conflicts with the requirements of the statute that established the 24 board, commission, task force, or multi-member body or entity.

25 As used in this section:

26 "Gender" means a person's sex-related or gender-related
27 characteristics, including one's gender identity and has the same
28 legal meaning as sex.

29 "Race" means the major groupings into which humankind is30 divided on the basis of physical characteristics or shared ancestry.

STATEMENT

2. This act shall take effect immediately.

37 This bill provides that, when the Governor, President of the 38 Senate, Speaker of the General Assembly, or any other person is 39 authorized by law to appoint a member to a board, commission, task 40 force, or any other multi-member body or entity established by law, 41 the Governor, President, Speaker, or other authorized person, as 42 appropriate, must make the goal of attaining a membership for such a board, commission, task force, or multi-member body or entity that 43 44 reflects the racial and gender diversity of the residents of the State a 45 primary consideration when selecting a person for appointment on or 46 after the effective date of the bill. The goal of attaining a membership 47 that reflects the racial and gender diversity of the residents of the 48 State will be a primary consideration by the appointing authority
