13	c. Prior to her appointment as the 22nd Commissioner of
14	Health, Commissioner Persichilli was the Chief Executive Officer
15	at St. Francis Medical Center in Trenton, President Emerita of
16	Catholic Health East Trinity Health, and the acting Chief Executive
17	Officer of University Hospital in Newark.
18	d. Commissioner Persichilli is the recipient of several honors
19	and awards, including induction into the New Jersey State Nurses
20	Association Hall of Honor in 2006, the 2008 Richard J. Hughes
21	Humanitarian Award, and the 2011 Edward J. Ill Excellence in
22	Medicine Award for Outstanding Medical Executive.
23	e. Throughout the COVID-19 pandemic, Commissioner
24	Persichilli has guided the State through the worst health crisis in
2526	100 years with her strong leadership and unflappable demeanor.f. Commissioner Persichilli's communication, collaboration,
27	and responsiveness during this time has been invaluable to the day-
28	to-day management of the pandemic.
29	g. It is appropriate that the new Department of Health State
30	building located at 55 North Willow Street in the City of Trenton
31	should bear the name of a woman who, through her tireless public
