Permits school district of residence to provide aid in-lieu-of transportation to pupil attending Marine Academy of Science and Technology provided certain conditions are met.

AN ACT concerning transportation to the Marine Academy of 1 2 Science and Technology and amending P.L.1983, c.341. 3 **BE IT ENACTED** by the Senate and General Assembly of the State 4 5 of New Jersey: 6 7 8 1. Section 6 of P.L.1983, c.341 (C.18A:54C-7) is amended to 9 read as follows: 10 6. Transportation for pupils attending the Marine Academy of 11 Science and Technology shall be provided by the district in which 12 the pupil resides; except that in the case of a pupil whose school 13 district of residence in not located in the county in which the 14 academy is located and the pupil resides more than 40 miles from the academy, then the parent, guardian, or other person having legal 15 16 custody of the pupil shall be eligible to receive the amount 17 determined pursuant to section 2 of P.L.1981, c.57 (C.18A:39-1a). 18 Notwithstanding the provisions of this section to the contrary, 19 pupils enrolled in and attending the regular full-time program at the 20 Marine Academy of Science and Technology on the effective date 21 of P.L., c. (pending before the Legislature as this bill) shall 22 receive transportation until graduation from the academy in 23 accordance with the provisions of this section as the same read prior to the effective date of P.L., c. (pending before the Legislature 24 25 as this bill). 26 (cf: P.L.1983, c.341, s.6) 27 28 This act shall take effect on July 1 of the first full school 2. year following the date of enactment. 29 30 31 32 **STATEMENT** 33 34 This bill revises the requirements for providing pupil 35 transportation to students attending the Marine Academy of Science 36 and Technology which is a county vocational school located in 37 Monmouth County. Currently, the school district in which a 38 student resides is required to provide transportation if a student 39 resides more than two and one-half miles from his county 40 vocational school of attendance, regardless of the distance to the 41 county vocational school or the cost of the transportation. This bill 42 would continue to require resident school districts to provide 43 transportation to all of their pupils attending the Marine Academy 44 of Science and Technology, except in the case of students who 45 reside outside of Monmouth County and more than 40 miles from

the academy. In this case the student's parent or guardian would be 1 2 eligible to receive the aid-in-lieu-of transportation amount, which in 3 the 2018-2019 school year is \$1,000. The bill also includes a 4 grandfather provision for these students residing outside the county 5 and more than 40 miles from the academy, if they are enrolled in 6 and attending the regular full-time program at the academy on the Under the grandfather provision, these bill's effective date. 7 students will continue to receive transportation from the resident 8 9 school district until graduation from the academy.
