SYNOPSIS

Requires person taking written examination for permit to watch video of rights and responsibilities of driver stopped by law enforcement.

AN ACT concerning motor vehicle driver education and testing, and
 amending R.S.39:3-10.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

1. R.S.39:3-10 is amended to read as follows:

8 39:3-10. A person shall not drive a motor vehicle on a public 9 highway in this State unless the person is under supervision while 10 participating in a behind-the-wheel driving course pursuant to section 11 6 of P.L.1977, c.25 (C.39:3-13.2a) or is in possession of a validated 12 permit, or a probationary or basic driver's license issued to that person 13 in accordance with this article.

14 A person under 18 years of age shall not be issued a basic license 15 to drive motor vehicles, and a person shall not be issued a validated 16 permit, including a validated examination permit, until the applicant 17 has passed a satisfactory examination and other requirements as to the 18 applicant's ability as an operator. The examination shall include: a test 19 of the applicant's vision; the applicant's ability to understand traffic 20 control devices; the applicant's knowledge of safe driving practices, 21 including the dangers of driving a vehicle in an aggressive manner, 22 which shall include, but not be limited to, unexpectedly altering the 23 speed of a vehicle, making improper or erratic traffic lane changes, 24 disregarding traffic control devices, failing to yield the right of way, 25 and following another vehicle too closely; the applicant's knowledge 26 of operating a motor vehicle in a manner that safely shares the 27 roadway with pedestrians, cyclists, skaters, riders of motorized-28 scooters, and other non-motorized vehicles, which shall include, but 29 not be limited to, passing a cyclist on the roadway, recognizing bicycle 30 lanes, navigating intersections with pedestrians and cyclists, and 31 exiting a vehicle without endangering pedestrians and cyclists; the 32 applicant's knowledge of the effects that ingestion of alcohol or drugs 33 has on a person's ability to operate a motor vehicle; the applicant's 34 knowledge of the dangers of carbon monoxide poisoning from motor 35 vehicles and techniques for the safe operation and proper maintenance 36 of a motor vehicle; the applicant's knowledge of portions of the 37 mechanism of motor vehicles as is necessary to insure the safe 38 operation of a vehicle of the kind or kinds indicated by the applicant; 39 and the applicant's knowledge of the laws and ordinary usages of the 40 road. The examination shall be made available in English and each of 41 the three languages, other than English, most commonly spoken in the 42 State, as determined by the chief administrator. The chief 43 administrator shall periodically, and at least every five years, verify the 44 three languages, other than English, most commonly spoken in the 45 State.

1 A person shall not sit for an examination for any permit without 2 exhibiting photo identification deemed acceptable by the commission, 3 unless that person is a high school student participating in a course of 4 automobile driving education approved by the State Department of 5 Education and conducted in a public, parochial, or private school of 6 this State, pursuant to section 1 of P.L.1950, c.127 (C.39:3-13.1).

Prior to taking an examination for ¹[a validated] any¹ permit, a
person shall watch a video created by the commission, in conjunction
with the Attorney General, explaining the rights and responsibilities of
a driver stopped by a law enforcement officer. ¹The video shall be
used for informational purposes only and shall not be used in any
criminal proceeding involving a driver stopped by a law enforcement
officer.¹

14 The commission may waive the written law knowledge 15 examination for any person 18 years of age or older possessing a valid 16 driver's license issued by any other state, the District of Columbia, or 17 the United States Territories of American Samoa, Guam, Northern 18 Mariana Islands, Puerto Rico, or the Virgin Islands. The commission 19 shall be required to provide that person with a booklet that highlights 20 those motor vehicle laws unique to New Jersey. A road test shall be 21 required for a probationary license and serve as a demonstration of the 22 applicant's ability to operate a vehicle of the class designated. During 23 the road test, an applicant may use a rear visibility system, parking 24 sensors, or other technology installed on the motor vehicle that enables 25 the applicant to view areas directly behind the vehicle or alerts the 26 applicant of obstacles while parking.

27 A person shall not sit for a road test unless that person exhibits 28 photo identification deemed acceptable by the commission. A high 29 school student who has completed a course of behind-the-wheel automobile driving education approved by the State Department of 30 31 Education and conducted in a public, parochial, or private school of 32 this State, who has been issued a special learner's permit pursuant to 33 section 1 of P.L.1950, c.127 (C.39:3-13.1) prior to January 1, 2003, 34 shall not be required to exhibit photo identification in order to sit for a 35 road test. The commission may waive the road test for any person 18 36 years of age or older possessing a valid driver's license issued by any 37 other state, the District of Columbia, or the United States Territories of 38 American Samoa, Guam, Northern Mariana Islands, Puerto Rico, or 39 the Virgin Islands. The road test shall be given on public streets, 40 where practicable and feasible, but may be preceded by an off-street 41 screening process to assess basic skills. The commission shall approve 42 locations for the road test which pose no more than a minimal risk of 43 injury to the applicant, the examiner, and other motorists. New 44 locations for the road test shall not be approved unless the test can be 45 given on public streets.

A person who successfully completes a road test for a motorcycle
license or a motorcycle endorsement when operating a motorcycle or
motorized scooter with an engine displacement of less than 231 cubic

1 centimeters shall be issued a motorcycle license or endorsement 2 restricting the person's operation of the vehicles to any motorcycle 3 with an engine displacement of 500 cubic centimeters or less. A 4 person who successfully completes a road test for a motorcycle license 5 or motorcycle endorsement when operating a motorcycle with an 6 engine displacement of 231 or more cubic centimeters shall be issued a 7 motorcycle license or endorsement without any restriction as to engine 8 displacement. Any person who successfully completes an approved 9 motorcycle safety education course established pursuant to the 10 provisions of section 1 of P.L.1991, c.452 (C.27:5F-36) shall be issued 11 a motorcycle license or endorsement without restriction as to engine 12 displacement.

13 A person issued a motorcycle license pursuant to this section may 14 be issued a standard motorcycle license or a REAL ID motorcycle 15 license. The chief administrator shall require an applicant for a 16 standard motorcycle license to provide as proof of the applicant's 17 identity, age, and residence primary and secondary documents, with 18 which the chief administrator shall attribute point values in accordance 19 with the point based identification verification program established 20 pursuant to section 28 of P.L.2003, c.13 (C.39:2A-28). The point total 21 required to prove the identity of an applicant for the standard 22 motorcycle license shall be the same for every applicant, regardless of 23 immigration status. In the event that the commission changes the point 24 total threshold, the requirement that every applicant reach the same 25 point total threshold shall remain in effect.

In addition to requiring the person to submit satisfactory proof of identity and age, the commission shall require the person to provide:

(1) as a condition for obtaining a standard motorcycle license,
proof of the person's social security number and one document
providing satisfactory proof that the person is a New Jersey resident.

31 If the person does not have a social security number, the person 32 shall either:

33 (a) provide satisfactory proof of an Individual Taxpayer34 Identification Number; or

(b) indicate, in a manner prescribed by the commission and
consistent with all other provisions of P.L.2019, c.271 (C.39:3-100 et
al.), that the person is not eligible to receive a social security number;
or

39 (2) as a condition for obtaining a REAL ID motorcycle license: 40 two documents providing satisfactory proof that the person is a New 41 Jersey resident; proof of the person's social security number or 42 verification of ineligibility for a social security number in accordance 43 with the "REAL ID Act of 2005," Pub.L.109-13, any acts amendatory 44 or supplementary thereto, and any federal regulations adopted 45 thereunder; and proof that the person's presence in the United States is 46 authorized under federal law.

47 A standard motorcycle license shall indicate that the license shall48 not be accepted as identification for an official purpose, as that term is

defined under the "REAL ID Act of 2005," Pub.L.109-13, any acts
 amendatory or supplementary thereto, and any federal regulations
 adopted thereunder.

4 The commission shall issue a standard basic driver's license or a 5 REAL ID basic driver's license to operate a motor vehicle other than a 6 motorcycle to a person over 18 years of age who previously has not 7 been licensed to drive a motor vehicle in this State or another 8 jurisdiction only if that person has: (1) operated a passenger 9 automobile in compliance with the requirements of this Title for not 10 less than one year, not including any period of suspension or 11 postponement, from the date of issuance of a probationary license 12 pursuant to section 4 of P.L.1950, c.127 (C.39:3-13.4); (2) not been 13 assessed more than two motor vehicle points; (3) not been convicted in 14 the previous year for a violation of R.S.39:4-50, section 2 of P.L.1981, 15 c.512 (C.39:4-50.4a), section 1 of P.L.1992, c.189 (C.39:4-50.14), 16 R.S.39:4-129, N.J.S.2C:11-5, section 1 of P.L.2017, c.165 (C.2C:11-17 5.3), subsection c. of N.J.S.2C:12-1, or any other motor vehicle-related 18 violation the commission determines to be significant and applicable 19 pursuant to regulation; and (4) passed an examination of the 20 applicant's ability to operate a motor vehicle pursuant to this section.

21 The commission shall expand the driver's license examination by 22 20 percent. The additional questions to be added shall consist solely of 23 questions developed in conjunction with the Department of Health 24 concerning the use of alcohol or drugs as related to highway safety. 25 The commission shall develop, in conjunction with the Department of 26 Health, supplements to the driver's manual which shall include 27 information necessary to answer any question on the driver's license 28 examination concerning alcohol or drugs as related to highway safety.

29 Up to 20 questions may be added to the examination on subjects to 30 be determined by the commission that are of particular relevance to 31 youthful drivers, including the importance of operating a motor vehicle 32 in a manner that safely shares the roadway with pedestrians, cyclists, 33 skaters, riders of motorized-scooters, and other non-motorized 34 vehicles, which shall include, but not be limited to, passing a cyclist on 35 the roadway, recognizing bicycle lanes, navigating intersections with 36 pedestrians and cyclists, and exiting a vehicle without endangering 37 pedestrians and cyclists, and the dangers of driving a vehicle in an 38 aggressive manner, which shall include, but not be limited to, 39 unexpectedly altering the speed of a vehicle, making improper or 40 erratic traffic lane changes, disregarding traffic control devices, failing 41 to yield the right of way, and following another vehicle too closely, 42 after consultation with the Director of the Division of Highway Traffic 43 Safety in the Department of Law and Public Safety.

The commission shall expand the driver's license examination to include a question asking whether the applicant is aware of the provisions of the "Revised Uniform Anatomical Gift Act," P.L.2008, c.50 (C.26:6-77 et al.) and the procedure for indicating on the driver's

license the intention to make a donation of body organs or tissues
 pursuant to section 1 of P.L.1978, c.181 (C.39:3-12.2).

The commission shall expand the driver's license examination to include a question asking whether the applicant is aware of the dangers of failing to comply with this State's motor vehicle traffic laws and the "STOP for Nikhil Safety Pledge" set forth in subsection e. of R.S.39:3-41.

8 The commission shall expand the driver's license examination to 9 include questions concerning the dangers of carbon monoxide 10 poisoning from motor vehicles and techniques for the safe operation 11 and proper maintenance of a motor vehicle.

12 Any person applying for a driver's license to operate a motor 13 vehicle or motorized bicycle in this State shall surrender to the commission any current driver's license issued to the applicant by 14 15 another state or jurisdiction upon the applicant's receipt of a driver's 16 license for this State. The commission shall refuse to issue a driver's 17 license if the applicant fails to comply with this provision. An 18 applicant for a permit or license who is under 18 years of age, and who 19 holds a permit or license for a passenger automobile issued by another 20 state or country that is valid or has expired within a time period 21 designated by the commission, shall be subject to the permit and 22 license requirements and penalties applicable to State permit and 23 license applicants who are of the same age; except that if the other 24 state or country has permit or license standards substantially similar to 25 those of this State, the credentials of the other state or country shall be 26 acceptable.

The commission shall create classified licensing of driverscovering the following classifications:

29 a. Motorcycles, except that for the purposes of this section, 30 motorcycle shall not include any three-wheeled motor vehicle 31 equipped with a single cab with glazing enclosing the occupant, seats 32 similar to those of a passenger vehicle or truck, seat belts and 33 automotive steering or any vehicle defined as a motorcycle pursuant to 34 R.S.39:1-1 having a motor with a maximum piston displacement that 35 is less than 50 cubic centimeters or a motor that is rated at no more 36 than 1.5 brake horsepower with a maximum speed of no more than 35 37 miles per hour on a flat surface.

b. Omnibuses as classified by R.S.39:3-10.1 and school busesclassified under N.J.S.18A:39-1 et seq.

c. (Deleted by amendment, P.L.1999, c.28)

40

d. All motor vehicles not included in classifications a. and b. A
license issued pursuant to this classification d. shall be referred to as
the "basic driver's license" and may be issued as a standard basic
driver's license or a REAL ID basic driver's license.

Every applicant for a license under classification b. shall be a holder of a basic driver's license. Any issuance of a license under classification b. shall be by endorsement on the person's basic driver's license.

1

1 A driver's license for motorcycles may be issued separately, but if 2 issued to the holder of a basic driver's license, it shall be by 3 endorsement on the person's basic driver's license. The holder of a 4 basic driver's license or a separately issued motorcycle license shall be 5 authorized to operate a motorcycle having a motor with a maximum piston displacement that is less than 50 cubic centimeters or a motor 6 7 that is rated at no more than 1.5 brake horsepower with a maximum 8 speed no more than 35 miles per hour on a flat surface.

9 The commission, upon payment of the lawful fee and after it or a 10 person authorized by it has examined the applicant and is satisfied of 11 the applicant's ability as an operator, may, in its discretion, issue a 12 license to the applicant to drive a motor vehicle. The license shall 13 authorize the person to drive any registered vehicle, of the kind or 14 kinds indicated.

The license shall expire, except as otherwise provided, during the fourth calendar year following the date in which the license was issued and on the same calendar day as the person's date of birth. If the person's date of birth does not correspond to a calendar day of the fourth calendar year, the license shall expire on the last day of the person's birth month.

21 The commission may, at its discretion and for good cause shown, issue licenses that expire on a date fixed by it. If the commission 22 issues a REAL ID basic driver's license or REAL ID motorcycle 23 24 license to a person who has demonstrated authorization to be present 25 in the United States for a period of time shorter than the standard 26 period of the license, the commission shall fix the expiration date of 27 the license at a date based on the period in which the person is 28 authorized to be present in the United States under federal immigration 29 laws. The commission may renew the person's REAL ID basic driver's 30 license or REAL ID motorcycle license only if it is demonstrated that 31 the person's continued presence in the United States is authorized under federal law. The fee for licenses with expiration dates fixed by 32 33 the commission shall be fixed by the commission in amounts 34 proportionately less or greater than the fee herein established.

The required fee for a license for the license period shall be as follows, subject to adjustment pursuant to section 16 of P.L.2007, c.335 (C.39:2A-36.1):

38 Standard motorcycle license or endorsement: \$18.

39 REAL ID motorcycle license: \$29.

40 Omnibus or school bus endorsement: \$18.

41 Standard basic driver's license: \$18.

42 REAL ID basic driver's license: \$29.

The commission shall waive the payment of fees for issuance of omnibus endorsements whenever an applicant establishes to the commission's satisfaction that the applicant will use the omnibus endorsement exclusively for operating omnibuses owned by a nonprofit organization duly incorporated under Title 15 or 16 of the Revised Statutes or Title 15A of the New Jersey Statutes.

1 The commission shall issue licenses for the following license 2 period on and after the first day of the calendar month immediately 3 preceding the commencement of the period, the licenses to be effective 4 immediately.

5 All applications for renewals of licenses shall be made in a manner 6 prescribed by the commission and in accordance with procedures 7 established by it.

8 The commission in its discretion may refuse to grant a permit or 9 license to drive motor vehicles to a person who is, in its estimation, not 10 a proper person to be granted a permit or license, but a defect of the 11 applicant shall not debar the applicant from receiving a permit or 12 license unless it can be shown by tests approved by the commission 13 that the defect incapacitates the applicant from safely operating a 14 motor vehicle.

15 A person issued a basic driver's license pursuant to this section 16 may be issued a standard basic driver's license or a REAL ID basic 17 driver's license. The chief administrator shall require an applicant for 18 a standard basic driver's license to provide as proof of the applicant's 19 identity, age, and residence primary and secondary documents, with 20 which the chief administrator shall attribute point values in accordance 21 with the point based identification verification program established pursuant to section 28 of P.L.2003, c.13 (C.39:2A-28). The point total 22 23 required to prove the identity of an applicant for the standard basic 24 driver's license shall be the same for every applicant, regardless of 25 immigration status. In the event that the commission changes the point 26 total threshold, the requirement that every applicant reach the same 27 point total threshold shall remain in effect.

In addition to requiring an applicant for a driver's license to submit satisfactory proof of identity and age, the commission also shall require the applicant to provide:

(1) as a condition for obtaining a permit and standard basic driver's
license, proof of the person's social security number and one document
providing satisfactory proof that the applicant is a New Jersey resident.
If the person does not have a social security number, the person shall
either:

36 (a) provide satisfactory proof of an Individual Taxpayer37 Identification Number; or

(b) indicate, in a manner prescribed by the commission and
consistent with all other provisions of P.L.2019, c.271 (C.39:3-100 et
al.), that the person is not eligible to receive a social security number;
or

(2) as a condition for obtaining a REAL ID basic driver's license:
two documents providing satisfactory proof that the applicant is a New
Jersey resident; proof of the applicant's social security number or
verification of ineligibility for a social security number in accordance
with the "REAL ID Act of 2005," Pub.L.109-13, any acts amendatory
or supplementary thereto, and any federal regulations adopted

thereunder; and proof that the applicant's presence in the United States
 is authorized under federal law.

A standard basic driver's license shall indicate that the license shall not be accepted as identification for an official purpose, as that term is defined under the "REAL ID Act of 2005," Pub.L.109-13, any acts amendatory or supplementary thereto, and any federal regulations adopted thereunder.

8 If the commission has reasonable cause to suspect that any 9 document presented by an applicant pursuant to this section is altered, 10 false, or otherwise invalid, the commission shall refuse to grant the 11 permit or license until the time when the document may be verified by 12 the issuing agency to the commission's satisfaction.

13 A person violating this section shall be subject to a fine not 14 exceeding \$500 or imprisonment in the county jail for not more than 15 60 days, but if that person has never been licensed to drive in this State 16 or any other jurisdiction, the applicant shall be subject to a fine of not 17 less than \$200 and, in addition, the court shall issue an order to the 18 commission requiring the commission to refuse to issue a license to 19 operate a motor vehicle to the person for a period of not less than 180 20 The penalties provided for by this paragraph shall not be days. 21 applicable in cases where failure to have actual possession of the 22 operator's license is due to an administrative or technical error by the 23 commission.

Nothing in this section shall be construed to alter or extend the
expiration of any license issued prior to the date this amendatory and
supplementary act becomes operative.

27 Any documents and personal information, including an applicant's 28 photograph, obtained by the commission from an applicant for a 29 standard basic driver's license or standard motorcycle license shall be 30 confidential, shall not be considered a government record pursuant to 31 P.L.1963, c.73 (C.47:1A-1 et seq.), P.L.2001, c.404 (C.47:1A-5 et al.), 32 or the common law concerning access to government records, and 33 shall not be disclosed by the commission for any purpose related to 34 Title 8 of the United States Code without the informed consent of the 35 applicant, a warrant signed by a State or federal judge, or a lawful 36 court order or subpoena; except that nothing in this section shall be 37 construed to prohibit, or in any way restrict, any action where such 38 prohibition or restriction would be contrary to federal law. When 39 responding to a warrant, court order, or subpoena, the commission 40 may disclose only those records or information specifically requested 41 in the warrant, court order, or subpoena.

42 Possession of a standard basic driver's license or standard 43 motorcycle license issued pursuant to this section shall not be 44 considered evidence of an individual's citizenship or immigration 45 status and shall not be used as a basis for an investigation, arrest, 46 citation, prosecution, or detention.

47 Information regarding an applicant's Individual Tax Identification48 Number, social security number, or ineligibility to receive a social

1 security number obtained by the commission for the issuance of a 2 standard motorcycle license or standard basic driver's license pursuant 3 to this section, shall not be considered a government record pursuant to 4 P.L.1963, c.73 (C.47:1A-1 et seq.), P.L.2001, c.404 (C.47:1A-5 et al.), 5 or the common law concerning access to government records, and 6 shall not be disclosed by the commission except where: (1) required by 7 section 11 of P.L.1998, c.1 (C.2A:17-56.60); (2) the applicant provides 8 written informed consent to the disclosure; (3) the requesting entity 9 presents a warrant signed by a State or federal judge, a lawful court 10 order, or a subpoena; (4) required by State or federal law, and to the 11 extent that the disclosure may be necessary to permit the State to 12 participate in the National Driver Register program, as set forth in 49 13 U.S.C. s.30301 et seq.; or (5) the disclosure is in connection with an 14 audit or investigation of identity fraud, driver's license fraud, or non-15 driver identification card fraud.

16 As used in this section:

17 "Parking sensors" means proximity sensors which use either18 electromagnetic or ultrasonic technology and are designed to alert the19 driver to obstacles while parking.

20 "Rear visibility system" means devices or components installed on
21 a motor vehicle at the time of manufacture that allow a forward facing
22 driver to view a visual image of the area directly behind the vehicle.

25 2. This act shall take effect on the first day of the seventh
26 month after enactment, but the Chief Administrator of the New
27 Jersey Motor Vehicle Commission may take any anticipatory
28 administrative action necessary for the timely implementation of
29 this act.
