Allows public libraries to dispose of certain materials without advertising for bids.

1 AN ACT concerning the disposal of certain public library materials 2 and amending P.L.1968, c.227. 3 4 **BE IT ENACTED** by the Senate and General Assembly of the State 5 of New Jersey: 6 7 1. Section 1 of P.L.1968, c.227 (C.40:33-8.1) is amended to 8 read as follows: 9 40:33-8.1. The county library commission of any county or the 10 board of trustees of any regional library established by 2 or more 11 counties may, within the limits of funds appropriated or otherwise 12 made available to the commission or board, purchase the following 13 without advertising for bids therefor: (1) library materials including 14 books. periodicals, newspapers, documents, pamphlets, 15 photographs, reproductions, microforms, pictorial or graphic works, 16 musical scores, maps, charts, globes, sound recordings, slides, 17 films, filmstrips, video and magnetic tapes, other printed or 18 published matter, and audiovisual and other materials of a similar 19 nature; (2) necessary binding or rebinding of library materials; and 20 (3) specialized library services. 21 The county library commission or the board of trustees may 22 dispose of the following without advertising for bids therefor: 23 library materials including books, periodicals, newspapers, documents, pamphlets, photographs, reproductions, microforms, 24 25 pictorial or graphic works, musical scores, maps, charts, globes, 26 sound recordings, slides, films, filmstrips, video and magnetic 27 tapes, other printed or published matter, and audiovisual and other 28 materials of a similar nature. 29 (cf: P.L.1968, c.227, s.1) 30 31 2. Section 2 of P.L.1968, c.227 (C.40:54-12.1) is amended to 32 read as follows: 33 40:54-12.1. The board of trustees of the free public library of 34 any municipality or of a joint free public library may, within the 35 limits of funds appropriated or otherwise made available to the board, purchase the following without advertising for bids therefor: 36 37 (1) library materials including books, periodicals, newspapers, 38 documents, pamphlets, photographs, reproductions, microforms, 39 pictorial or graphic works, musical scores, maps, charts, globes, 40 sound recordings, slides, films, filmstrips, video and magnetic 41 tapes, other printed or published matter, and audiovisual and other 42 materials of a similar nature; (2) necessary binding or rebinding of 43 library materials; and (3) specialized library services. 44 The board of trustees may dispose of the following without 45 advertising for bids therefor: library materials including books,

This act shall take effect immediately. 9 10 11 **STATEMENT** 12 13 Under current law, a county library commission and the board of 14 trustees of any regional, municipal, or joint public library may 15 purchase certain library materials without advertising for bids. 16 These library materials include: books, periodicals, newspapers, 17 documents, pamphlets, photographs, reproductions, microforms, 18 pictorial or graphic works, musical scores, maps, charts, globes, 19 sound recordings, slides, films, filmstrips, video and magnetic 20 tapes, other printed or published matter, and audiovisual and other materials of a similar nature. 21 22 This bill amends that law to allow public libraries to also dispose 23 of those materials without advertising for bids.
