Requires DOLWD to take measures to ensure One-Stop Career Centers reopen immediately and remain open during public health emergency.

**BE IT ENACTED** by the Senate and General Assembly of the State of New Jersey:

6 1. a. For the duration of the public health emergency and state 7 of emergency declared on March 9, 2020 by the Governor, pursuant to Executive Order No. 103 and extended, where applicable, by 8 9 subsequent executive orders the Commissioner of the New Jersey 10 Department of Labor and Workforce Development shall take all 11 measures necessary to ensure that a One-Stop Career Center reopen 12 immediately and remain open and ensure that the department and its 13 agencies continue to provide services to individuals, including, but 14 not limited to, assistance with unemployment insurance and the 15 resolution of unemployment claims. If the commissioner determines 16 that the temporary closure of a One-Stop Career Center is 17 necessary, the department shall provide reasonable alternatives to 18 prospective customers of that location.

b. On or before the 90th day following the effective date of this
act, the commissioner shall submit a written report to the Governor
and the Legislature on the measures taken in the prior 90 days to
comply with the provisions of this act and to prevent the temporary
closure of One-Stop Career Centers.

c. The commissioner shall re-open any One-Stop Career Center
that is closed on the effective date of P.L., c. (C.) (pending
before the Legislature as this bill) as soon thereafter as is
practicable.

This act shall take effect immediately and shall expire at the 30 end of the public health emergency caused by the coronavirus 31 disease 2019 pandemic, either: upon the expiration of Executive 32 Order No. 103 of 2020 and any subsequent executive orders 33 extending the public health emergency; or, in the absence of a 34 rescission by the Governor, upon the termination in any other 35 manner of the declared public health emergency.

### STATEMENT

40 This bill requires the Commissioner of the Department of Labor 41 and Workforce Development to take all measures necessary to 42 ensure that a One-Stop Career Center reopen immediately and 43 remain open and ensure that the department and its agencies 44 continue to provide services to individuals, including assistance 45 with unemployment insurance. If the commissioner determines that 46 the temporary closure of a One-Stop Career Center is necessary, the 47 department is required to provide reasonable alternatives to 48 prospective customers of that agency location. The commissioner is
