Makes supplemental appropriation of \$8 million to DHS to increase reimbursement for funeral, burial, and crematory services provided to certain beneficiaries of Work First New Jersey and Supplemental Security Income programs.

1 A SUPPLEMENT to the annual appropriations act for the fiscal year 2 ending June 30, 2022, P.L.2021, c.133. 3 4 **BE IT ENACTED** by the Senate and the General Assembly of the 5 State of New Jersey: 6 7 1. The Director of the Division of Family Development shall 33 determine the method for allocating the appropriated amount, provided that: 1) the funds shall be allocated to county and 34 35 municipal agencies in such a manner that all eligible 36 reimbursements of funeral, burial, and crematory services provided to eligible persons pursuant to N.J.A.C.10:90-8.2 are 37 increased equally in proportion to the total cost of the service 38 39 provided; and 2) the funds shall not supplant other amounts allocated for the reimbursement of funeral, burial, and crematory 40 41 services provided to eligible persons pursuant to N.J.A.C.10:90-42 8.2 that are included in appropriations under P.L.2021, c.133. 43 44 2. This act shall take effect immediately.

STATEMENT

3 This bill makes a FY 2022 supplemental appropriation of \$8 4 million to the Division of Family Development (DFD) in the 5 Department of Human Services (DHS) to increase reimbursements issued to funeral homes and cemeteries for funeral, burial, and 6 7 crematory services provided to eligible persons in the Work First 8 New Jersey (WFNJ) and Supplemental Security Income (SSI) 9 programs, as outlined under N.J.A.C.10:90-8.2. It is the sponsor's 10 goal to provide a reasonable increase in the reimbursement for these 11 services to ensure that New Jersey funeral homes and cemeteries can 12 continue to provide services to the State's most needy and vulnerable 13 residents.

14 Under the State's existing system, county and municipal agencies are responsible for processing claims and issuing payments for 15 16 reimbursement of services to funeral directors and cemetery 17 representatives. As such, under the bill, the Director of the Division 18 of Family Development is to determine the method for allocating the 19 funds to all applicable county and municipal agencies, provided that 20 the funds are allocated in such a manner that all eligible 21 reimbursements are increased equally in proportion to the total cost 22 of the service provided.

23 Furthermore, the bill provides that the director is not to use the \$8 24 million to supplant other amounts allocated for the reimbursement of 25 funeral, burial, and crematory services that are included in the FY 26 2022 Appropriations Act. According to FY 2022 Budget documents, 27 the department anticipates the division will expend \$15.8 million for 28 such expenses in the existing fiscal year. This supplement, therefore, 29 will increase total expenditures for such services to \$23.8 million.

30 Currently, pursuant to section 3 of P.L.1985, c.282 (C.44:1-31 157.1.), the total allowable payment for funeral, burial, and 32 crematory services, including contributions by others, is to be at least 33 75 percent of the average cost for a proper funeral and burial charged 34 by funeral directors in the locality in which the public assistance 35 recipient is buried or cremated. Under N.J.A.C.10:90-8.5, however, 36 the maximum allowance for adult funeral and cemetery services is 37 \$2,770. In addition, family and friends can contribute up to \$1,570 without affecting the benefit amount. Therefore, current regulation 38 39 establishes the total allowable payment for funeral, burial, and 40 crematory services, including contributions by others, at \$4,340.

41 Based upon data provided by the New Jersey State Funeral 42 Directors Association, \$4,340 is only approximately 28 percent of 43 the average cost of funeral and cemetery charges in 2021, or \$15,268. 44 As such, the current funding policy leaves a funding gap of over 45 \$7,000 per funeral and burial provided under the WFNJ and SSI 46 programs, according to the statutory provision that the allowable 47 payment for services is to be at least 75 percent of the average cost 48 for a proper funeral and burial, which in 2021 would be \$11,452.
