A CONCURRENT RESOLUTION applying to the Congress of the 1 2 United States for the calling of an Article V Convention of States 3 for the purpose of limiting certain powers of the federal 4 government. 5 WHEREAS, The Founders of our Constitution empowered state 6 7 legislators to be guardians of liberty against future abuses of power 8 by the federal government; and 9 WHEREAS, The federal government has created a crushing national 10 debt through improper and imprudent spending; and WHEREAS, The federal government has invaded the legitimate roles of 11 12 the states through the manipulative process of federal mandates, 13 most of which are unfunded to a great extent; and 14 WHEREAS, The federal government has ceased to live under a proper 15 interpretation of the Constitution of the United States; and WHEREAS, It is the solemn duty of the states to protect the liberty 16 17 of our people, particularly for the generations to come, to 18 propose amendments to the Constitution of the United States, 19 and to place clear restraints on these and related abuses of power; 20 now, therefore, 21 22 BE IT RESOLVED by the Senate of the State of New Jersey (the 23 General Assembly concurring): 24 25 1. The Legislature of the State of New Jersey makes 26 application to the Congress of the United States, for the calling of an Article V Convention of the States for the limited purpose of 27 28 proposing amendments to the Constitution of the United States that 29 impose fiscal restraints on the federal government, limit the power 30 and jurisdiction of the federal government, and limit the terms of office for its officials and for members of Congress. 31 32 33 This application constitutes a continuing application in 2. accordance with Article V of the Constitution of the United States 34 35 until the Legislatures of at least two-thirds of the several states have 36 made applications on the same subject. 37 38 3. Copies of this resolution, as filed with the Secretary of State, 39 shall be transmitted by the Clerk of the General Assembly or the Secretary of the Senate to the President and Vice President of the 40 41 United States, the Speaker of the United States House of Representatives, the Minority Leader of the United States House of 42 43 Representatives, the President Pro Tempore of the United States 44 Senate, each Senator and Representative from New Jersey in the 45 Congress of the United States, the Governor of each state, and the 46 presiding officer of each house of each state legislature in the 47 United States, requesting their cooperation.

This Senate concurrent resolution applies to Congress for the calling of an Article V Convention of the States limited to proposing amendments to the United States Constitution that impose fiscal restraints on the federal government, limit the power and jurisdiction of the federal government and limit the terms of office for its officials.
