1 AN ACT concerning special child protection license plates and  
2 supplementing chapter 3 of Title 39 of the Revised Statutes.

3  
4 **BE IT ENACTED** *by the Senate and General Assembly of the State*  
5 *of New Jersey:*

6  
7 1. a. The Director of the Division of Motor Vehicles shall, upon  
8 proper application therefor, issue child protection license plates for  
9 any motor vehicle owned or leased and registered in this State. In  
10 addition to the registration number and other markings or  
11 identification otherwise prescribed by law, a child protection license  
12 plate shall display words or a slogan and an emblem indicating support  
13 for, and an interest in, protecting children through the establishment  
14 of assessment and treatment programs for parents with substance  
15 abuse problems who have had their children removed from the home  
16 due to a finding of abuse or neglect. The words or slogan and emblem  
17 shall be chosen by the director, in consultation with the Commissioner  
18 of Human Services. Issuance of child protection license plates shall be  
19 subject to all applicable requirements of chapter 3 of Title 39 of the  
20 Revised Statutes, except as hereinafter otherwise specifically provided.

21 b. The director shall collect a \$50 application fee for the child  
22 protection license plates in addition to the fees otherwise prescribed  
23 by law for the registration of the motor vehicle. The director shall  
24 collect annually subsequent to the year of issuance of the license plate  
25 a \$10 fee for the license plate in addition to the fees otherwise  
26 prescribed by law for the registration of the motor vehicle. The  
27 additional fees required by this subsection shall be deposited into the  
28 Child Protection License Plate Fund established pursuant to subsection  
29 c. of this section.

30 c. There is created in the Department of Treasury a special non-  
31 lapsing fund to be known as the "Child Protection License Plate  
32 Fund." There shall be deposited in the fund the amount collected from  
33 all license plate fees collected pursuant to subsection b. of this section,  
34 less the amounts necessary to reimburse the division for administrative  
35 costs pursuant to subsection d. of this section. Moneys deposited in

1 the fund shall be dedicated exclusively to funding the substance abuse  
2 assessment and treatment programs required by P.L. , c. (C. )  
3 (now pending before the Legislature as Assembly Bill No. 1893).  
4 Moneys deposited in the fund shall be held in interest-bearing accounts  
5 in public depositories as defined pursuant to section 1 of P.L.1970,  
6 c.236 (C.17:9-41) and may be invested or reinvested in such securities  
7 as are approved by the State Treasurer. Interest or other income  
8 earned on moneys deposited into the fund, and any moneys which may  
9 be appropriated or otherwise become available for the purposes of the  
10 fund, shall be credited to and deposited in the fund for use as set forth  
11 in this act.

12 d. Prior to the deposit of license plate fees collected pursuant to  
13 subsection b. of this section into the fund, amounts thereof as are  
14 necessary shall be used to reimburse the division for all costs  
15 reasonably and actually incurred, as stipulated by the director, for:

16 (1) producing, issuing, renewing and publicizing the availability of  
17 child protection license plates; and

18 (2) any initial fees, in an amount not to exceed \$150,000, collected  
19 from the issuance of child protection license plates to be allocated to  
20 the division to pay the cost of any computer programming changes  
21 that may be necessary to implement the child protection license plate  
22 program established by this act.

23 The director shall annually certify to the State Treasurer the  
24 average cost per license plate incurred in the immediately preceding  
25 year by the division in producing, issuing, renewing and publicizing the  
26 availability of child protection license plates. The annual certification  
27 of the average cost per license plate shall be approved by the Joint  
28 Budget Oversight Committee or its successor.

29 If the average cost per license plate as certified by the director and  
30 approved by the Joint Budget Oversight Committee or its successor is  
31 greater than the \$50 application fee established in subsection b. of this  
32 section in two consecutive fiscal years, the director may discontinue  
33 the issuance of child protection license plates.

34 e. The director shall notify eligible motorists of the opportunity to  
35 obtain child protection license plates by including a notice with all  
36 motor vehicle registration renewals, and by posting appropriate  
37 posters or signs in all division facilities and offices, as may be provided  
38 by the department. The notices, posters and signs shall be designed by  
39 the division in consultation with the commissioner.

40 f. The director, the commissioner and the State Treasurer shall  
41 develop and enter into an interagency memorandum of agreement  
42 setting forth the procedures to be followed by the department and the  
43 division in carrying out their respective responsibilities under this act.

45 2. This act shall take effect on the first day of the sixth month after  
46 enactment, but the director may take such anticipatory acts in advance

1 of that date as may be necessary for the timely implementation of this  
2 act upon its effective date.

#### STATEMENT

7 This bill requires the Director of the Division of Motor Vehicles in  
8 the Department of Transportation to issue special child protection  
9 license plates to persons interested in establishing programs to assess  
10 and treat parents with substance abuse problems who have had their  
11 children removed from the home due to abuse or neglect. In addition  
12 to the registration number and other markings or identification  
13 prescribed by law, a child protection license plate would display words  
14 or a slogan and an emblem chosen by the director, in consultation with  
15 the Commissioner of Human Services.

16 An application fee of \$50 and an annual renewal fee of \$10 would  
17 be required for the special plates in addition to all fees otherwise  
18 required by law for the registration of the motor vehicle. These  
19 additional fees, after the deduction of the cost of producing and  
20 publicizing the plates, are to be deposited in a special non-lapsing  
21 account known as the "Child Protection License Plate Fund." The  
22 proceeds are to be dedicated exclusively to funding substance abuse  
23 assessment and treatment programs established pursuant to pending  
24 legislation, the Senate Committee Substitute for Senate Bill Nos. 996  
25 and 1355. That bill requires parents who have had their children  
26 removed from the home due to a finding of abuse or neglect to be  
27 assessed and, when necessary, treated for substance abuse problems.  
28 The return of the child to the parental home is conditioned upon the  
29 parent's receipt of treatment and compliance with a treatment program.

30 The director is required to certify the average cost per unit in  
31 producing, issuing and publicizing the child protection license plates  
32 each year. If the average cost exceeds \$50 for two consecutive fiscal  
33 years, the director may discontinue the license plate program. The  
34 director would also be responsible for notifying eligible motorists of  
35 the availability of the plates.
