1 AN ACT concerning the "Waterfront Commission Compact,"  
2 P.L.1953, c.202 (C.32:23-1 et seq.), providing for the extension of  
3 the term of the license granted to stevedores pursuant to Article VI  
4 thereof, and amending P.L.1991, c.248.

6 **BE IT ENACTED** *by the Senate and General Assembly of the State*  
7 *of New Jersey:*

9 1. Section 1 of P.L.1991, c.248 (C.32:23-23.1) is amended to read  
10 as follows:

11 1. A stevedore's license shall, notwithstanding the provisions of  
12 Article VI, paragraph 5 of P.L.1953, c.202 (C.32:23-23) be for a term  
13 of ~~[three]~~five years or fraction of such ~~[three]~~five-year period, and  
14 shall expire on the first day of December. In the event of the death of  
15 the licensee, if a natural person, or its termination or dissolution by  
16 reason of the death of a partner, if a partnership, or if the licensee shall  
17 cease to be a party to any contract of the type required by subdivision  
18 (d) of paragraph 3 of Article VI (C.32:23-21), the license shall  
19 terminate 90 days after such event or upon its expiration date,  
20 whichever shall be sooner. A license may be renewed by the  
21 commission for successive ~~[three]~~five-year periods upon fulfilling the  
22 same requirements as are set forth in Article VI for an original  
23 application for a stevedore's license.

26 2. (New section) If any part or provision of this act or the  
27 application thereof to any person or circumstances be adjudged invalid  
28 by any court of competent jurisdiction, such judgment shall be  
29 confined in its operation to the part, provision or application directly  
30 involved in the controversy in which such judgment shall have been  
31 rendered and shall not affect or impair the validity of the remainder of  
32 this act or the application thereof to other persons or circumstances  
33 and the two states hereby declare that they would have entered into  
34 this act or the remainder thereof had the invalidity of such provisions

3 3. (New section) This act constitutes an agreement between the  
4 states of New Jersey and New York, supplementary to the waterfront  
5 commission compact and amendatory thereof, and shall be liberally  
6 construed to effectuate the purposes of said compact and the powers  
7 vested in the waterfront commission hereby shall be construed to be  
8 in aid of and supplemental to and not in limitation of or in derogation  
9 of any of the powers heretofore conferred upon or delegated to the  
10 waterfront commission.

12 4. This act shall take effect immediately but shall remain  
13 inoperative until the enactment into law by the State of New York of  
14 legislation of substantially similar substance and effect; but if such  
15 legislation already has been enacted, this act shall take effect  
16 immediately.

STATEMENT

21 This bill amends the "Waterfront Commission Compact," P.L.1953,  
22 c.202 (C.32:23-1 et seq.) between the State of New Jersey and the  
23 State of New York, and consented to by the Congress of the United  
24 States pursuant to the provisions of Pub.L.252, c.407, 67 Stat. 541 et  
25 seq., which regulates certain activities relating to waterborne freight.

26 The bill extends the licensing period for stevedores from three years  
27 to five years and authorizes the commission to review stevedore  
28 licenses for successive five-year rather than three-year periods.

29 For the provisions of this act to have the force of law, the State of  
30 New York must adopt substantially identical legislation.
