1 AN ACT approving projects of certain local government units in
2 northern New Jersey as eligible for funding with moneys made
3 available from the "Green Acres, Farmland and Historic
4 Preservation, and Blue Acres Bond Act of 1995," P.L.1995, c.204,
5 the "Green Acres, Clean Water, Farmland and Historic Preservation
6 Bond Act of 1992," P.L.1992, c.88, the "Open Space Preservation
7 Bond Act of 1989," P.L.1989, c.183, or the "New Jersey Green
8 Acres Bond Act of 1983," P.L.1983, c.354.

10 BE IT ENACTED by the Senate and General Assembly of the State
11 of New Jersey:

13 1. a. The following projects are eligible for funding with moneys
14 made available from the "Green Acres, Farmland and Historic
15 Preservation, and Blue Acres Bond Act of 1995," P.L.1995, c.204, the
16 "Green Acres, Clean Water, Farmland and Historic Preservation Bond
17 Act of 1992," P.L.1992, c.88, the "Open Space Preservation Bond Act
18 of 1989," P.L.1989, c.183, or the "New Jersey Green Acres Bond Act
19 of 1983," P.L.1983, c.354, and which moneys are appropriated or
20 reappropriated pursuant to sections 1 and 2 of P.L. , c. (now
21 before the Legislature as Senate Bill No. 2138 of 1997 or Assembly
22 Bill No. 2991 of 1997):

29 b. Any transfer of funds, or change in project sponsor, site, or
30 type, listed in subsection a. of this section shall require the approval of
31 the Joint Budget Oversight Committee or its successor.

32 c. To the extent that moneys remain available after the projects
33 listed in subsection a. of this section are offered funding pursuant
34 thereto, the local government unit projects listed in P.L.1984, c.224,
35 P.L.1985, c.479, P.L.1986, c.208, P.L.1988, c.23, P.L.1989, c.194,
36 P.L.1991, c.13, P.L.1991, c.14, P.L.1991, c.15, P.L.1991, c.16,
37 P.L.1991, c.522, P.L.1993, c.200, P.L.1993, c.201, P.L.1993, c.266,
38 P.L.1993, c.267, P.L.1994, c.37, P.L.1994, c.45, P.L.1994, c.51,
39 P.L.1994, c.52, P.L.1995, c.199, P.L.1995, c.200, P.L.1995, c.201,
40 P.L.1995, c.202, P.L.1995, c.203, P.L.1996, c.107, P.L.1996, c.108,
41 P.L.1996, c.109, P.L.1996, c.110, section 5 of P.L. , c. (now
42 before the Legislature as Senate Bill No. 2138 of 1997 or Assembly
43 Bill No. 2991 of 1997), section 1 of P.L. , c. (now before the
44 Legislature as Senate Bill No. 2139 of 1997 or Assembly Bill No.
45 2992 of 1997), and section 5 of P.L. , c. (now before the
46 Legislature as Senate Bill No. 2141 of 1997 or Assembly Bill No.
47 2994 of 1997), shall be eligible for funding or additional funding,

1 including administrative costs, in a sequence consistent with the
2 priority system established by the Department of Environmental
3 Protection. Any such transfer of funds, or change in project sponsor,
4 site, or type, shall require the approval of the Joint Budget Oversight
5 Committee or its successor.

10 STATEMENT

12 This bill would approve projects of certain local government units
13 in northern New Jersey as eligible for funding with moneys made
14 available from the "Green Acres, Farmland and Historic Preservation,
15 and Blue Acres Bond Act of 1995," P.L.1995, c.204, the "Green
16 Acres, Clean Water, Farmland and Historic Preservation Bond Act of
17 1992," P.L.1992, c.88, the "Open Space Preservation Bond Act of
18 1989," P.L.1989, c.183, or the "New Jersey Green Acres Bond Act of
19 1983," P.L.1983, c.354. The funding will be used to provide
20 low-interest loans or grants, or both, to assist the local government
21 units to acquire and develop lands for recreation and conservation
22 purposes, and includes administrative costs. The total sum of the
23 approved amounts for the northern New Jersey projects is
24 \$31,530,000. This bill is part of a four-bill legislative package
25 approving the funding of Green Acres or Blue Acres projects of local
26 government units around the State.

27 To the extent that there are funds remaining after those local
28 government unit projects in northern New Jersey listed in this bill are
29 offered funding, the bill also authorizes the Department of
30 Environmental Protection, with the approval of the Joint Budget
31 Oversight Committee, to use those funds for local government unit
32 projects listed in the three other Green Acres or Blue Acres "local
33 government" bills of this legislative package as well as for local
34 government unit projects previously approved for funding pursuant to
35 various acts implementing the 1983, 1987, 1989, 1992, and 1995
36 Green Acres bond acts.
