INTRODUCED JUNE 12, 1997

1 AN ACT concerning policies and procedures for contracting for certain
2 professional services by State agencies, and supplementing
3 P.L.1954, c.48 (C.52:34-6 et seq.).
4

5 **BE IT ENACTED** by the Senate and General Assembly of the State
6 of New Jersey:

7
8 1. It is the policy of this State that State contracts for architectural,
9 engineering and land surveying services shall be publicly announced
10 prior to being awarded and that contracts for these services shall be
11 negotiated on the basis of demonstrated competence and qualifications
12 for the type of professional services required and at fair and reasonable
13 compensation.
14

15 2. As used in this act:

16 "agency" means any of the principal departments in the Executive
17 Branch of State Government, and any division, board, bureau, office,
18 commission or other instrumentality created by a principal department
19 and any independent State authority, commission, instrumentality or
20 agency, which is authorized by law to contract for professional
21 architectural, engineering or land surveying services;

22 "compensation" means the basis of payment by an agency for
23 professional architectural, engineering or land surveying services;

24 "professional firm" means any individual, firm, partnership,
25 corporation, association or other legal entity permitted by law to
26 ¹[practice architecture,] provide professional architectural,¹
27 engineering, or land surveying ¹services¹ in this State;

28 "professional architectural, engineering and land surveying services"
29 means those services, including planning, environmental, and
30 construction inspection services required for the development and
31 construction of projects, within the scope of practice of architecture,

1 professional engineering or professional land surveying as defined by
2 the laws of this State or those performed by an architect, professional
3 engineer or professional land surveyor in connection with his
4 professional employment practice.

5
6 3. A professional firm which wishes to be considered qualified to
7 provide professional architectural, engineering, or land surveying
8 services to an agency seeking to negotiate a contract or agreement for
9 the performance of such services shall file or shall have filed with the
10 agency a current statement of qualifications and supporting data. Such
11 a statement may be filed at any time during a calendar year. The
12 content of any such statement shall conform to such regulations with
13 respect thereto as the State Treasurer, in accordance with the
14 "Administrative Procedure Act," P.L.1968, c.410 (C.52:14B-1 et
15 seq.), shall promulgate. For the purposes of this section and section
16 5 of this act, no statement which shall have been filed more than ¹[one
17 year] two years¹ prior to the publication of an advertisement pursuant
18 to the provisions of section 4 of this act shall be deemed to be a
19 current statement with respect to qualification of the firm which shall
20 have filed the statement to provide professional architectural,
21 engineering, or land surveying services under any contract or
22 agreement of which notice is given through that advertisement.

23 A statement of qualifications and supporting data filed with an
24 agency under this section shall be a public record for all purposes of
25 P.L.1963, c.73 (C.47:1A-1 et seq.).

26
27 4. Notwithstanding the provisions of sections 2 through 4 of
28 P.L.1954, c.48 (C.52:34-7 through 52:34-9), a contract or agreement
29 with an agency for the procurement of professional architectural,
30 engineering, or land surveying services shall be ¹[made, negotiated, or
31 awarded only after public advertisement of notice that such a contract
32 or agreement is to be made or awarded] publicly advertised prior to
33 the solicitation of proposals or expressions of interest from interested
34 firms¹. To the extent consistent with the purposes and provisions of
35 this section, the ¹[notice] advertisement¹ shall conform to the
36 requirements applicable under subsections (a) and (b) of section 7 of
37 P.L.1954, c.48 (C.52:34-12) ¹[to an advertisement for bids] or may be
38 publicly advertised through electronic means¹. The advertisement shall
39 include a statement of the criteria ¹[, established as provided under
40 subsection b. of section 5 of this act,]¹ by which the agency seeking to
41 procure those professional services shall evaluate the technical
42 qualifications of professional firms and¹ determine the order of
43 preference to be used in designating the firms most highly qualified to
44 perform the services; this statement shall either set forth explicitly and
45 in full the terms of those criteria or identify them by reference to the
46 regulation or regulations in which those criteria shall have been

1 promulgated as required by subsection c. of ¹[that]¹ section 5 ¹of this
2 act¹. In addition, the advertisement shall include notice that
3 professional firms wishing to be considered for selection as a potential
4 provider of such services in connection with a proposed project must
5 have submitted to the agency a current statement of qualifications and
6 supporting data as prescribed in section 3 of this act.

7
8 5. a. In the procurement of architectural, engineering and land
9 surveying services, no agency shall make, negotiate, or award a
10 contract or agreement for the performance of such services with or to
11 any professional firm which has not filed with the agency a current
12 statement of qualifications and supporting data as prescribed under
13 section 3 of this act.

14 b. For each proposed project, an agency shall evaluate current
15 statements of qualifications and supporting data on file with the
16 agency. ¹[If desired, the] The¹ agency may solicit ¹[statements of
17 qualifications] proposals or expressions of interest¹ unique to the
18 specific project which would in narrative form outline design concepts
19 and proposed methods of approach to the assignment. The agency
20 shall select, in order of preference, based upon ¹the¹ criteria
21 ¹[established by the agency, no fewer than] included in the
22 advertisement required by section 4 of this act, at least¹ three
23 professional firms deemed to be the most highly qualified to provide
24 the services required ¹, except that the agency may select fewer
25 professional firms if fewer such firms responded to the solicitation or
26 meet the qualifications required for the project¹.

27 c. An agency which intends or expects to make, negotiate or award
28 a contract or agreement for the procurement of professional
29 architectural, engineering, or land surveying services shall, before
30 publishing an advertisement of notice with respect to any such
31 contract or agreement, have adopted by regulation and have
32 promulgated, in accordance with the "Administrative Procedure Act,"
33 P.L.1968, c.410 (C.52:14B-1 et seq.), the criteria by which it shall
34 with respect to any such contract or agreement make the selection of
35 qualified firms as prescribed by subsection b. of this section. The
36 provisions of this subsection shall not be construed to require the
37 adoption by an agency of regulations regarding the selection criteria
38 to be applicable with respect to a particular contract if such
39 regulations were previously promulgated and remain in effect with
40 respect to such a contract.

41
42 6. An agency shall negotiate a contract with the most ¹technically¹
43 qualified professional firm for architectural, engineering or land
44 surveying services at compensation which the agency determines to be
45 fair and reasonable to the State of New Jersey. In making this
46 ¹[decision] determination¹, the agency shall take into account the

1 estimated value of the services to be rendered and the scope,
2 complexity, and professional nature thereof. Should the agency be
3 unable to negotiate a satisfactory contract with the professional firm
4 considered to be the most qualified at a fee the agency determines to
5 be fair and reasonable, negotiations with that professional firm shall be
6 formally terminated. The agency shall then undertake negotiations
7 with the second most qualified professional firm. Failing accord with
8 the second most qualified professional firm, the agency shall formally
9 terminate negotiations. The agency shall then undertake negotiations
10 with the third most qualified professional firm. Should the agency be
11 unable to negotiate a satisfactory contract with any of the selected
12 professional firms, it shall select additional professional firms in order
13 of their competence and qualifications and it shall continue
14 negotiations in accordance with this section until an agreement is
15 reached.

17 7. ¹[The] Notwithstanding the provisions of section 2 of P.L.1954,
18 c.48 (C.52:34-7) to the contrary, the¹ provisions of this act shall only
19 apply to contracts for architectural, engineering and land surveying
20 services in excess of \$25,000. Nothing in this act shall preclude a
21 State agency from using procurement processes other than those
22 prescribed herein if those processes have been approved by the federal
23 government ¹or other State statute¹ or if an emergency has been
24 declared by the chief executive officer of the agency.

26 8. This act shall take effect ¹[immediately] on the 360th day after
27 enactment but an agency may take such anticipatory administrative
28 action in advance as shall be necessary for the implementation of the
29 act¹.

34 Provides that State contracts for architectural, engineering and land
35 surveying services would be subject to a process of competitive
36 negotiation and would not be publicly bid.
