INTRODUCED DECEMBER 15, 1997

1 AN ACT Appropriating funds to the Department of Corrections from
2 the "Public Purpose Buildings and Community-Based Facilities
3 Construction Fund" for the expansion of various correctional
4 facilities.

6 BE IT ENACTED by the Senate and General Assembly of the State
7 of New Jersey:

9 1. There is appropriated to the Department of Corrections from the
10 "Public Purpose Buildings and Community-Based Facilities
11 Construction Fund" created pursuant to the "Public Purpose Buildings
12 and Community-Based Facilities Construction Bond Act of 1989,"
13 P.L.1989, c.184, the sum of \$8,926,336 for the following projects:

17 Jones Farm

18 Construct 200-bed dormitory
19 unit with support building.....\$7,020,000

21 Northern State Prison

22 Adjusted Final contract cost for
23 additional beds.....\$1,540,659

25 Emergency security upgrades at Northern
26 and Riverfront State Prisons.....\$ 365,677

27 Total Appropriation.....\$8,926,336

29 2. There is also appropriated from the "Public Purpose Buildings
30 and Community-Based Facilities Construction Fund," such amounts as
31 may be necessary to meet any expense incurred by the issuing officials
32 under P.L.1989, c.184 for advertising, engraving, printing, clerical,
33 legal or other services necessary to carry out the duties imposed upon
34 them by the provisions of that act.

36 3. In order to provide flexibility in administering the provisions of
37 this act, the Commissioner of the Department of Corrections may

1 apply to the Director of the Division of Budget and Accounting in the
2 Department of the Treasury for permission to transfer a part of any
3 item to any other item within the respective department accounts in the
4 "Public Purpose Buildings and Community-Based Facilities
5 Construction Fund" account. The transfers shall be made in a manner
6 consistent with section 29 of P.L.1989, c.184.

8 4. This act shall take effect immediately.

11 STATEMENT

13 This bill would appropriate \$8,926,336 to the Department of
14 Corrections from the "Public Purpose Buildings and Community Based
15 Facilities Construction Fund" created pursuant to the "Public Purpose
16 Buildings and Community-Based Facilities Construction Bond Act of
17 1989" for the construction of a new 200-bed dormitory unit with
18 support building at the Jones Farm facility, the adjusted final contract
19 cost for additional beds constructed at Northern State Prison and
20 emergency security upgrades at Northern and Riverfront State Prisons.
