## **SENATE RESOLUTION No. 48**

## **STATE OF NEW JERSEY**

## INTRODUCED MAY 30, 1996

## By Senators BUBBA and BASSANO

1	A SENATE RESOLUTION memorializing Congress to enact HR 3286,
2	concerning tax incentives for prospective adoptive parents.
3	
4	WHEREAS, Currently there are 500,000 children in foster care throughout the
5	United States; 49% of those children are minorities. These children often
6	languish in foster homes, deprived of the unique bond shared by a parent
7	and child, whether natural or adoptive, causing them to develop emotional
8	and psychological problems and making it more difficult for them to grow
9	into healthy, productive and independent adults; and
10	WHEREAS, HR 3286, entitled the "Adoption Promotion and Stability Act of
11	1996," now pending in the United States House of Representatives,
12	provides tax credits for families who are interested in adopting special
13	needs children; and
14	WHEREAS, Only about 50,000 adoptions are approved each year in this
15	country, some of them at exorbitant costs. This makes it more difficult for
16	individuals, interested in providing stable and loving homes to children in
17	foster care, to adopt. Tax credits would help prospective adoptive families
18	defray adoption costs and create a system where no child is denied access
19	to loving parents and a healthy home; and
20	WHEREAS, It is the obligation of the federal government to remove all barriers
21	to the adoption process so children do not have to wait to be placed in
22	permanent homes; HR 3286 would provide incentives to make it easier
23	for families to adopt children in need; now, therefore,
24	
25	Be It Resolved by the Senate of the State of New Jersey:
26	
27	1. The Congress of the United States is respectfully memorialized to
28	enact HR 3286, entitled the "Adoption Promotion and Stability Act of 1996,"
29	which provides tax credits for families who are interested in adopting special
30	needs children.

32	2. Duly authenticated copies of this resolution, signed by the President of
33	the Senate and attested by the Secretary thereof, shall be transmitted to the
34	presiding officers of the Congress of the United States and each member of
35	New Jersey's Congressional delegation.
