

## SYNOPSIS

Requires Police Training Commission to contract with crisis intervention training center to provide mental health training to police officers and establish curriculum specific to persons experiencing economic crisis or substance use disorder.

**AN ACT** concerning police training and supplementing chapter 17B of Title 52 of the Revised Statutes.

**BE IT ENACTED** by the Senate and General Assembly of the State
of New Jersey:

1. a. <sup>2</sup><u>The Attorney General, in consultation with the</u> 7 Commissioner of Human Services, shall develop a pilot program to 8 9 promote and encourage law enforcement officers Statewide to 10 complete training that applies the Crisis Intervention Team model, which program may include support for and coordination between 11 12 the Police Training Commission in the Division of Criminal Justice 13 in the Department of Law and Public Safety and the Division of Mental Health and Addiction Services in the Department of Human 14 15 Services to increase the frequency of, number of locations, and 16 geographic accessibility to training courses offered that apply the Crisis Intervention Team model. 17

18 <u>b.</u><sup>2</sup> The Police Training Commission <sup>2</sup>[in the Division of
 19 Criminal Justice in the Department of Law and Public Safety]<sup>2</sup>
 20 <sup>1</sup>shall<sup>1 2</sup>[:

(1) <sup>1</sup>[shall]<sup>1</sup> annually contract with <sup>1</sup>[the New Jersey Crisis 21 Intervention Team Center of Excellence] a crisis intervention 22 training center<sup>1</sup> to assist and support counties in developing and 23 implementing the Crisis Intervention Team model. 24 The Police 25 Training Commission shall assume and maintain any existing 26 contract between <sup>1</sup>[the New Jersey Crisis Intervention Team Center of Excellence] <u>a crisis intervention training center</u><sup>1</sup> and the 27 Division of Mental Health and Addiction Services in the 28 Department of Human Services <sup>1</sup>that is<sup>1</sup> in operation upon the 29 30 effective date of this act. as part of the officer's in-service training;

14 "Crisis Intervention Team model" means the best practice jail 15 diversion model originally developed by the Memphis Tennessee 16 Police Department and implemented in New Jersey as a county 17 based collaboration of professionals committed to improving the 18 law enforcement and mental health systems' response to persons 19 experiencing a psychiatric crisis who come into contact with law 20 enforcement first responders.

21 <sup>1</sup>["New Jersey Crisis Intervention Team Center of Excellence"] "Crisis intervention training center"<sup>1</sup> means <sup>1</sup>[a program of the 22 Mental Health Association in Southwestern New Jersey serving] a 23 program or entity that has operated<sup>1</sup> as a <sup>1</sup>crisis intervention<sup>1</sup> 24 support center <sup>1</sup>in the State for a period of at least five years and 25 <sup>2</sup>[<u>is contracted, pursuant to subsection a. of this section</u>,<sup>1</sup> to assist] 26 that has experience in assisting political subdivisions in<sup>2</sup> New 27 Jersey <sup>2</sup>[counties]<sup>2</sup> in developing and implementing the Crisis 28 Intervention Team model. 29 30

31 2. This act shall take effect <sup>2</sup>[on the first day of the thirteenth
32 month next following the date of enactment] <u>immediately</u><sup>2</sup>.
