SYNOPSIS

Alters procedure for reimbursing nurses who provide nonpublic school nursing services in certain circumstances.

1 AN ACT concerning the provisions of nursing services to nonpublic 2 school students and supplementing P.L.1991, c.226 (C.18A:40-3 23 et seq.). 4 5 **BE IT ENACTED** by the Senate and General Assembly of the State 6 of New Jersey: 7 8 1. a. Notwithstanding the provisions of any law or regulation 9 to the contrary, the State aid provided to a school district pursuant 10 to section 9 of P.L.1991, c.226 (C.18A:40-31) shall be distributed by the school district directly to the individual providing nursing 11 12 services for the nonpublic school, if the following conditions are 13 met: 14 (1) the nonpublic school provides to the school district all 15 required documentation attesting to the individual's status as a 16 registered nurse licensed by the New Jersey State Board of Nursing; 17 (2) the nonpublic school provides to the school district 18 documentation of the actual hours the individual provided nursing 19 services at the nonpublic school; and 20 (3) the nonpublic school, on a form developed by the 21 Department of Education, submits to the school district: 22 (a) an attestation that all documentation provided to the school 23 district pursuant to this section is valid; and 24 (b) an agreement to assume any liability that may arise if the 25 individual is determined not to be a registered nurse licensed by the 26 New Jersey State Board of Nursing during the school year. 27 If the conditions set forth pursuant to paragraphs (1), (2), and (3) 28 of this subsection are not met, then the school district shall not 29 distribute State aid directly to the individual providing nursing 30 services for the nonpublic school as permitted under this section. 31 (1) The provisions of this section shall not apply to a school b. 32 district that entered into an agreement for the provision of nursing 33 services for nonpublic schools for the 2020-2021 school year prior 34 to the effective date of this act. The provisions of this section shall 35 apply to a school district that renews an agreement, or enters into a 36 new agreement, for the provision of nursing services for nonpublic 37 schools for the 2021-2022 school year, and any subsequent school 38 year, after the effective date of this act. 39 (2) A nonpublic school shall notify a school district of its 40 intention to meet all of the conditions set forth in paragraphs (1), 41 (2), and (3) of subsection a. of this section prior to renewing or 42 entering into a new agreement with the school district for the 43 provision of nursing services for the nonpublic school pursuant to 44 the provisions of this section. The provisions of this paragraph 45 shall not be construed as requiring a nonpublic school to meet all of 46 the conditions set forth in paragraphs (1), (2), and (3) of subsection 47 a. of this section, even if it notifies the school district of its

The provisions of this section shall not be construed as prohibiting a school district from using funds provided to the school 4 5 district pursuant to section 9 of P.L.1991, c.226 (C.18A:40-31) for administrative purposes. 6 7 8 2. This act shall take effect immediately. 9 10 **STATEMENT** 11 12 13 This bill permits, under certain circumstances, a school district to 14 provide State aid directly to an individual that is providing nursing 15 services for a nonpublic school. 16 Under P.L.1991, c.226 (C.18A:40-23 et seq.), a board of 17 education is required to provide certain basic nursing services for 18 nonpublic school students enrolled at a nonpublic school located within the district, and the board is permitted to provide certain 19 20 other nursing services to the nonpublic school students. Under this 21 bill, the State aid provided to a school district for the provisions of 22 nonpublic school nursing services will be distributed by the school 23 district directly to the individual providing nursing services to the 24 nonpublic school students if the following conditions are met: 25 (1) the nonpublic school provides to the school district all 26 required documentation attesting to the individual's status as a 27 registered nurse licensed by the New Jersey State Board of Nursing; (2) the nonpublic school provides to the school district 28 29 documentation of the actual hours the individual provided nursing 30 services at the nonpublic school; and 31 (3) the nonpublic school, on a form developed by the 32 Department of Education, submits to the school district an 33 attestation that all documentation provided to the school district is 34 valid and an agreement to assume any liability that may arise if the 35 individual is determined not to be a registered nurse licensed by the New Jersey State Board of Nursing during the school year. 36 37 The bill also provides that the provisions of the bill will not 38 apply to a school district that entered into an agreement for the 39 provision of nursing services for nonpublic schools for the 2020-40 2021 school year prior to the effective date of the bill. The 41 provisions of the bill will apply to a school district that renews an 42 agreement, or enters into a new agreement, for the provision of 43 nursing services for nonpublic schools for the 2021-2022 school 44 year and any subsequent school year, after the effective date of the 45 bill 46 Finally, the bill requires a nonpublic school, prior to renewing or 47 entering a new agreement with a school district for the provision of 48 nursing services for the nonpublic school, to notify the school
