1 **AN ACT** concerning project grants under the “Securing Our
 2 Children’s Future Fund” to provide career and technical
 3 education at county colleges and making an appropriation.
 4

5 **BE IT ENACTED** *by the Senate and General Assembly of the State*
 6 *of New Jersey:*
 7

8 1. a. There is appropriated from the “Securing Our Children’s
 9 Future Fund,” established pursuant to section 13 of P.L.2018, c.119, to
 10 the Secretary of Higher Education the sum of \$25,956,996 to provide
 11 career and technical education grants to county colleges. Project grants
 12 shall be approved in the amounts set forth in subsection b. of this
 13 section.

14 b. Project grants shall be awarded in the amounts as follows:

15 (1) \$4,000,000 to Atlantic Cape Community College in Mays
 16 Landing, Atlantic County;

17 (2) \$1,937,711 to Brookdale Community College in Lincroft,
 18 Monmouth County;

19 (3) \$4,000,000 to County College of Morris in Randolph, Morris
 20 County;

21 (4) \$2,737,317 to Hudson County Community College in Jersey
 22 City, Hudson County;

23 (5) \$4,000,000 to Mercer County Community College in West
 24 Windsor, Mercer County;

25 (6) \$2,997,691 to Middlesex County College in Edison, Middlesex
 26 County;

27 (7) \$2,104,752 to Ocean County College in Toms River, Ocean
 28 County;

29 (8) \$2,650,500 to Union County College in Cranford, Union
 30 County; and

31 (9) \$1,529,025 to Warren County Community College in West
 32 Washington, Warren County.

34 2. There is appropriated from the “Securing Our Children’s
 35 Future Fund” to the Office of the Secretary of Higher Education the
 36 sum of \$500,000 for the administrative costs of the agency in
 37 implementing the provisions of the “Securing Our Children’s Future
 38 Bond Act,” P.L.2018, c.119.
 39

40 3. The expenditure of sums appropriated by this act shall be
 41 subject to the provisions and conditions of the “Securing Our
 42 Children’s Future Bond Act,” P.L.2018, c.119.

44 4. This act shall take effect immediately.

STATEMENT

This bill appropriates a total of \$26,456,996 from the “Securing Our Children’s Future Fund.” Under the bill, \$25,956,996 is appropriated for career and technical education grants to the State’s county colleges. The bill also appropriates \$500,000 to the Office of the Secretary of Higher Education for the administration of the “Securing Our Children’s Future Bond Act.”

Provides project grants under “Securing Our Children’s Future Fund” for career and technical education at county colleges; appropriates \$26,456,996.
