SYNOPSIS

Requires school bus drivers to retake certain knowledge and skills tests.

Section 4 of P.L.1990, c.103 (C.39:3-10.12) is amended to 8 read as follows: 9 4. Notwithstanding any other provision of law to the a. 10 contrary, the chief administrator shall adopt and administer a classified licensing system and a program for testing and ensuring 11 12 the fitness of persons to operate commercial motor vehicles in accordance with the minimum federal standards established under 13 the federal "Commercial Motor Vehicle Safety Act of 1986," Pub. 14 15 L. 99-570 (49 U.S.C. s. 2701 et seq.) and the regulations 16 promulgated pursuant to that law. The chief administrator shall not 17 issue a commercial driver license to a person unless that person 18 passes a knowledge and skills test for the operation of a commercial 19 motor vehicle which complies with the federal standards. The chief 20 administrator may issue commercial driver examination or learner's 21 permits, subject to such conditions and restrictions as deemed necessary, to carry out the provisions of [this act] P.L.1990, c.103 22 23 (C.39:3-10.9 et seq.). 24 b. A knowledge and skills test shall not be required by the chief 25 administrator for the renewal of a commercial driver license issued pursuant to the provisions of [this act] P.L.1990, c.103 (C.39:3-26 27 10.9 et seq.). However, a knowledge and skills test may be required 28 for (1) the renewal of an endorsement permitting the operation of 29 vehicles required to be placarded for hazardous materials, (2) [for] 30 the renewal or reissuance of a commercial driver license if the 31 license was suspended or revoked under section 12 of [this act] 32 P.L.1990, c.103 (C.39:3-10.20) during the last license period 33 preceding the renewal or reissuance, or (3) [for] the renewal or 34 reissuance of a license which had not been renewed for a period of 35 three or more years. A knowledge and skills test shall be required 36 to maintain a school bus endorsement as provided pursuant to this 37 subsection. 38 A person with a school bus endorsement shall pass a school bus 39 endorsement knowledge test and school bus endorsement skills test 40 every five years in order to maintain the school bus endorsement, 41 except that a person with a school bus endorsement who is 70 years 42 of age or older shall pass a school bus endorsement knowledge test 43 and school bus endorsement skills test every year in order to 44 maintain the school bus endorsement. 45 Upon the request of an applicant for a commercial driver с.

1 license, the chief administrator shall administer to the applicant oral 2 knowledge tests for the commercial driver license and any 3 endorsements if the applicant supplies sufficient proof or otherwise 4 demonstrates to the satisfaction of the chief administrator [his] the 5 applicant's inability to comprehend a written test. For the purposes of an application for a commercial driver 19 license by a person who has never held a license issued under the 20 provisions of [this act] P.L.1990, c.103 (C.39:3-10.9 et seq.), a 21 person who satisfactorily completes the knowledge test for the 22 commercial driver license but not the test for an endorsement, or a 23 person who satisfactorily completes the knowledge test for an 24 endorsement but not the test for the commercial driver license, shall 25 not be required to retake that test which was satisfactorily 26 completed.

No provision in [this act] P.L.1990, c.103 (C.39:3-10.9 et 28 seq.), or in any manual, test, or administrative procedure developed 29 to implement the provisions of [this act] P.L.1990, c.103 (C.39:3-30 10.9 et seq.), shall be deemed to expand the requirements for 31 commercial motor vehicle operators concerning pre-trip inspection, 32 after-trip inspection, and inspection during a trip as such 33 requirements are set forth in federal law or regulation. This 34 subsection, however, shall not be deemed to limit the authority of 35 the chief administrator, or the authority of any State department or 36 agency, to promulgate, pursuant to other provisions of State law, 37 standards and procedures on vehicle inspections which are 38 consistent with federal law and regulation.

This bill requires a person with a school bus endorsement to This bill requires a person with a school bus endorsement to retake the school bus endorsement knowledge test and the school bus endorsement skills test every five years in order to maintain the school bus endorsement. A person who is 70 years of age or older is required, under the bill, to retake the school bus endorsement knowledge test and school bus endorsement skills test every year in order to maintain the school bus endorsement.
