SYNOPSIS

Exempts honorably discharged veterans from payment of passenger motor vehicle registration fee; requires notification of eligible motorists.

1 AN ACT concerning certain motor vehicle registration fee
2 exemptions for certain veterans and supplementing Title 39 of
3 the Revised Statutes.

5 **BE IT ENACTED** *by the Senate and General Assembly of the State*
6 *of New Jersey:*

8 1. a. The Chief Administrator of the New Jersey Motor
9 Vehicle Commission shall not charge a fee for the registration of a
10 motor vehicle of passenger type, which is not to be used for hire,
11 and that is owned by any resident of this State, individually or
12 jointly with a spouse, who is an honorably discharged veteran. The
13 chief administrator, after consultation with the Adjutant General of
14 the Department of Military and Veterans' Affairs, shall determine
15 the manner for application and the documentation that an honorably
16 discharged veteran shall use to provide proof of eligibility for the
17 registration fee exemption.

18 b. The Adjutant General of the Department of Military and
19 Veterans' Affairs, in consultation with the chief administrator, shall
20 notify all eligible motorists of the availability of the registration fee
21 exemption provided for pursuant to subsection a. of this section.

22 c. As used in this section, "honorably discharged veteran"
23 means an individual who served on active duty in the Armed Forces
24 of the United States, a Reserve component thereof, or the National
25 Guard, who received an honorable discharge, and has received
26 documentation that provides proof of the honorable discharge as
27 determined by the Adjutant General of the Department of Military
28 and Veterans' Affairs.

30 2. This act shall take effect on the first day of the sixth month
31 after enactment, but the Adjutant General of the Department of
32 Military and Veterans' Affairs and the Chief Administrator of the
33 New Jersey Motor Vehicle Commission may take such
34 administrative action in advance of that date as shall be necessary
35 for the timely implementation of this act.

38 STATEMENT

40 This bill prohibits the Chief Administrator of the New Jersey
41 Motor Vehicle Commission (chief administrator) from charging a
42 fee for the registration of a motor vehicle of passenger type, which
43 is not to be used for hire, that is owned by any resident of this State,
44 individually or jointly with a spouse, who is an "honorably
45 discharged" veteran as defined in the bill. The bill requires the
46 chief administrator, after consultation with the Adjutant General of
47 the Department of Military and Veterans' Affairs (adjutant general),
48 to determine the manner for application and the documentation that

1 an honorably discharged veteran is to use to provide proof of
2 eligibility for the registration fee exemption. The bill requires the
3 adjutant general, in consultation with the chief administrator, to
4 notify all eligible motorists of the availability of the fee exemption.
