SYNOPSIS

Establishes child care costs reimbursement grant program in DCF for parents or guardians whose children are subject to quarantine as a result of COVID-19; appropriates \$500,000.

1 AN ACT establishing a child care costs reimbursement grant 2 program in the Department of Children and Families, 3 supplementing Title 30 of the Revised Statutes, and making an 4 appropriation. 5 6 **BE IT ENACTED** by the Senate and General Assembly of the State 7 of New Jersey: 8 9 1. As used in this act: 10 "Eligible parent or guardian" means an individual who: (1) is employed full-time or part-time; and (2) has a child who is enrolled 11 12 or will be enrolled in a child care center licensed pursuant to the 13 provisions of P.L.1983, c.492 (C.30:5B-1 et seq.) and who is subject to quarantine as a result of an exposure to the coronavirus 14 15 disease 2019 (COVID-19). 16 17 2. a. There is established in the Department of Children and 18 Families a grant program in which an eligible parent or guardian with shall be reimbursed for child care tuition costs incurred by the 19 20 parent or guardian during the period the parent or guardian's child 21 is quarantined as a result of an exposure to the coronavirus disease 22 2019 (COVID-19) at the child care center where the child is or will 23 be enrolled. 24 b. The grant program established pursuant to subsection a. of 25 this section shall be funded from monies appropriated thereto by 26 section 4 of this act, and any other monies as may be appropriated 27 or otherwise made available for that purpose. 28 29 3. a. An eligible parent or guardian who wishes to participate in the grant program established under section 2 of this act shall 30 31 submit an application to the Commissioner of Children and 32 Families, in a manner and on forms as determined by the 33 commissioner. 34 b. The commissioner shall: 35 (1) establish selection criteria for awarding grants under the 36 program; 37 (2) award grants under the program based upon review of the 38 applications and subject to the limit of funds appropriated or 39 otherwise made available for the program; 40 (3) allocate the approved grant funds to each eligible parent or 41 guardian participating in the program in a timely manner; and 42 (4) establish the amount of each grant awarded for an eligible 43 parent or guardian. 44 c. The grant awarded to an eligible parent or guardian pursuant 45 to subsection b. of this section shall be used to reimburse child care 46 tuition costs incurred by the parent or guardian during the period 47 the parent or guardian's child is quarantined as a result of an 3

1 exposure to the coronavirus disease 2019 (COVID-19) at the child 2 care center where the child is or will be enrolled. 3 4. There is appropriated \$500,000 from a portion of the block 4 5 grant funds allocated to the State from the federal "American Rescue Plan Act of 2021," Pub.L.117-2, to the Department of 6 7 Children and Families for the grant program established in section 2 8 of this act, to the extent the funding is available for this purpose 9 10 The Department of Children and Families shall adopt, 5. 11 pursuant to the "Administrative Procedure Act," P.L.1968, c.410 12 (C.52:14B-1 et seq.), rules and regulations necessary for the 13 implementation of this act. 14 15 6. This act shall take effect on the first day of the third after the 16 date of enactment, except that the Commissioner of Children and 17 Families may take any anticipatory administrative action in advance 18 as shall be necessary for the implementation of this act. 19 20 21 **STATEMENT** 22 23 This bill establishes in the Department of Children and Families 24 a grant program in which an eligible parent or guardian will be 25 reimbursed for child care tuition costs incurred by the parent or 26 guardian during the time the parent or guardian's child is 27 quarantined as a result of an exposure to the coronavirus disease 2019 (COVID-19) at the child care center where the child is or will 28 29 be enrolled. 30 As used in the bill, "eligible parent or guardian" means an 31 individual who: is employed full-time or part-time; and has a child 32 who is enrolled or will be enrolled in a child care center licensed 33 pursuant to the provisions of P.L.1983, c.492 (C.30:5B-1 et seq.) 34 and who is subject to quarantine as a result of an exposure to 35 COVID-19. The grant program is to be funded from \$500,000 appropriated to 36 37 the DCF from a portion of the block grant funds allocated to the State from the federal "American Rescue Plan Act of 2021," 38 39 Pub.L.117-2, and any other monies appropriated or made available 40 for the grant program. 41 Under the provisions of the bill, an eligible parent or guardian 42 who wishes to participate in the grant program is to submit an application to the Commissioner of Children and Families 43 44 (commissioner), in a manner and on forms determined by the 45 commissioner. The commissioner is to: (1) establish selection 46 criteria for awarding grants under the program; (2) award grants 47 under the program based upon review of the applications and 48 subject to the limit of funds appropriated or otherwise made

1 available for the program; (3) allocate the approved grant funds to each eligible parent or guardian participating in the program in a 2 3 timely manner; and (4) establish the amount of each grant awarded 4 for an eligible parent or guardian. 5 The bill stipulates that the grant awarded to an eligible parent or 6 guardian will be used to reimburse child care tuition costs incurred 7 by the parent or guardian during the period the parent or guardian's 8 child is quarantined as a result of an exposure to the coronavirus

9 disease 2019 (COVID-19) at the child care center where the child is

10 or will be enrolled.
