Eliminates smoking ban exemption for casinos and simulcasting facilities.

AN ACT amending P.L.2005, c.383, the "New Jersey Smoke-Free 1 2 Air Act." 3 4 **BE IT ENACTED** by the Senate and General Assembly of the State 5 of New Jersey: 6 1. Section 5 of P.L.2005, c.383 (C.26:3D-59) is amended to 7 8 read as follows: 9 5. The provisions of this act shall not apply to: 10 a. any cigar bar or cigar lounge that, in the calendar year 11 ending December 31, 2004, generated 15 percent or more of its total 12 annual gross income from the on-site sale of tobacco products and 13 the rental of on-site humidors, not including any sales from vending 14 machines, and is registered with the local board of health in the municipality in which the bar or lounge is located. The registration 15 16 shall remain in effect for one year and shall be renewable only if: 17 (1) in the preceding calendar year, the cigar bar or lounge generated 18 15 percent or more of its total annual gross income from the on-site 19 sale of tobacco products and the rental of on-site humidors, and (2) 20 the cigar bar or cigar lounge has not expanded its size or changed 21 its location since December 31, 2004; 22 b. any tobacco retail establishment, or any area the tobacco 23 retail establishment provides for the purposes of smoking; 24 any tobacco business when the testing of a cigar or pipe c. 25 tobacco by heating, burning or smoking is a necessary and integral 26 part of the process of making, manufacturing, importing, or 27 distributing cigars or pipe tobacco; 28 d. private homes, private residences and private automobiles; 29 e. **[**the area within the perimeter of: 30 (1) any casino as defined in section 6 of P.L.1977, c.110 31 (C.5:12-6) approved by the Casino Control Commission that 32 contains at least 150 stand-alone slot machines, 10 table games, or 33 some combination thereof approved by the commission, which 34 machines and games are available to the public for wagering; and 35 (2) any casino simulcasting facility approved by the Casino 36 Control Commission pursuant to section 4 of P.L.1992, c.19 37 (C.5:12-194) that contains a simulcast counter and dedicated seating 38 for at least 50 simulcast patrons or a simulcast operation and at least 39 10 table games, which simulcast facilities and games are available 40 to the public for wagering;] (Deleted by amendment, P.L., c.) 41 (pending before the Legislature as this bill) 42 f. research laboratories and other facilities that have been 43 approved by the Department of Health to permit smoking for the 44 purpose of medical research related to the health effects of smoking, 45 in an indoor facility that is separately ventilated for the purpose

This act shall take effect immediately. 28 29 30 **STATEMENT** 31 32 This bill amends the "New Jersey Smoke-Free Air Act," 33 P.L.2005, c.383 (C.26:3D-55 et seq.), to prohibit smoking in 34 casinos and casino simulcasting facilities. Current law prohibits 35 smoking in most indoor public places and workplaces, with certain 36 exceptions, including indoor public places and workplaces which 37 are within the perimeter of casinos and casino simulcasting 38 facilities and accessible to the public for wagering. This bill would 39 eliminate these exceptions from the smoking ban. 40 The National Institute for Occupational Safety and Health found 41 that casino workers are at greater risk for lung and heart disease 42 because of secondhand smoke, and a study in the Journal of 43 Occupational and Environmental Medicine found that the air in 44 casinos can have up to 50 times more cancer-causing particles than 45 the air on rush-hour highways.
