1 AN ACT establishing the School Funding Formula Evaluation Task 2 Force.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

7 There is established the School Funding Formula 1. a. 8 Evaluation Task Force. The purpose of the task force shall be to 9 study, evaluate, and assess the provision of State school aid pursuant to the "School Funding Reform Act of 2008," P.L.2007, 10 c.260 (C.18A:7F-43 et al.). 11

12 b. The task force shall consist of seven members, as follows: 13

(1) the Commissioner of Education or a designee; and

14 (2) six public members, each of whom shall have educational 15 experience and expertise in education and municipal finance and school budgeting. Two of the members shall be appointed by the 16 17 Senate President, two of the members shall be appointed by the 18 Speaker of the General Assembly, one shall be appointed by the 19 Minority Leader of the Senate, and one shall be appointed by the Minority Leader of the General Assembly. 20

c. The appointments to the task force shall be made within 30 21 22 days of the effective date of this act. Vacancies in the membership 23 of the task force shall be filled in the same manner as the original 24 appointments were made. Members of the task force shall serve 25 without compensation but shall be reimbursed for necessary 26 expenditures incurred in the performance of their duties as members of the task force within the limits of funds appropriated or 27 28 otherwise made available to the task force for its purposes.

29 The task force shall organize as soon as practicable, but no d. 30 later than 30 days following the appointment of its members. The 31 task force shall choose a chairperson from among its members and 32 shall appoint a secretary who need not be a member of the task 33 force.

34 e. (1) The task force shall hold meetings at the request of the 35 chairperson and shall hold a minimum of three public meetings, 36 which shall each be held in the northern, central, and southern 37 regions of the State. The meetings may take place in-person or 38 through remote means. It shall be the purpose of the public 39 meetings to seek input and gather testimony on the effects of the 40 State's current school funding formula and potential areas for 41 improvement within the formula from education stakeholders 42 including, but not limited to, education finance experts, school 43 leaders, school business officials, school board members, and 44 members of the public.

45 During meetings of the task force, the Department of (2)46 Education shall make available to the members of the task force and 47 to the public the data inputs and calculations used by the department in formulating State school aid for all school districts 48

under the "School Funding Reform Act of 2008," P.L.2007, c.260 1 2 (C.18A:7F-43 et al.) and P.L.2018, c.67 (C.18A:7F-67 et al.) 3 including, but not limited to, the software program algorithm used 4 by the department to annually determine the property value rate and 5 the income value rate pursuant to subsection c. of section 10 of 6 P.L.2007, c.260 (C.18A:7F-52). 7 The Department of Education shall f. provide such 8 stenographic, clerical, and other administrative assistants, and such 9 professional staff as the task force requires to carry out its work. The task force also shall be entitled to call to its assistance and avail 10 itself of the services of the employees of any State, county, or 11 12 municipal department, board, bureau, commission, or agency as it 13 may require and as may be available for its purposes. 14 15 2. It shall be the duty of the task force to study the effectiveness of, and provide recommendations on potentially 16 17 improving, various aspects of the "School Funding Reform Act of 18 2008," P.L.2007, c.260 (C.18A:7F-43 et al.), including, but not 19 limited to: a. the manner in which school district adequacy budgets and 20 local shares are calculated; 21 22 b. the current methodology of measuring and weighting at-risk 23 students and students with limited English proficiency and the 24 impacts on the educational outcomes of those students; 25 c. the weights applied to students in different grade levels, as 26 well as those applied to students enrolled in county vocational 27 school districts; 28 d. the current methodology used to calculate the geographic cost 29 adjustment; 30 e. the use of the census-based funding methodology used in the formula for determining the amount of State aid a school district 31 32 receives to educate its special education population and the effects 33 of potentially employing different methodologies; 34 f. the provision of extraordinary special education aid and the 35 cost thresholds used as the bases for reimbursement of 36 extraordinary special education costs; 37 g. the methodologies used to calculate security categorical aid 38 and transportation aid; and 39 h. the impact that the reallocation of State school aid pursuant to P.L.2018, c.67 (C.18A:7F-67 et al.) had on school districts' 40 41 finances. 42 43 3. The task force shall issue a final report detailing its findings and recommendations to the Governor, and to the Legislature 44 45 pursuant to section 2 of P.L.1991, c.164 (C.52:14-19.1) no later 46 than one year after the organization of the task force. The report 47 shall be posted in a prominent location on the Internet website of
