SYNOPSIS

Allows dogs in sampling and tasting areas of breweries.

**CURRENT VERSION OF TEXT** As introduced.



1 AN ACT concerning breweries and supplementing Title 33 of the 2 **Revised Statutes.** 3 4 **BE IT ENACTED** by the Senate and General Assembly of the State 5 of New Jersey: 6 7 1. A dog may be allowed in any area of the licensed premises of a limited brewery licensed pursuant to R.S.33:1-10 designated 8 9 for the consumption of malt alcoholic beverages, provided that: 10 a. the holder of the limited brewery license elects to allow dogs 11 to be present in the area of the licensed premises designated for the 12 consumption of malt alcoholic beverages; 13 dogs do not have access to any area of the licensed premises b. 14 where the presence of the dog would present a risk of contamination 15 of malt alcoholic beverages or other products produced for human consumption by the brewery; 16 17 c. the area of the licensed premises designated for the consumption of malt alcoholic beverages where dogs are allowed 18 can be accessed without passing through any areas of the licensed 19 20 premises where the presence of a dog would present a risk of contamination of malt alcoholic beverages or other products 21 22 produced for human consumption by the brewery; 23 d. the presence of dogs in the area of the licensed premises 24 designated for the consumption of malt alcoholic beverages does 25 not result in contamination of any clean equipment, glassware, 26 utensils, or other articles used in connection with furnishing 27 samples of malt alcoholic beverages to consumers; e. staff members are not allowed, while on duty, to have any 28 29 direct contact with dogs, and any staff member who does have 30 direct contact with a dog while on duty shall promptly wash the 31 staff member's hands in accordance with State public health and 32 sanitation requirements; 33 the area of the licensed premises that is designated for the f. 34 consumption of malt alcoholic beverages is maintained in a clean condition, and surfaces that have been contaminated by a dog's 35 excrement or bodily fluids are promptly cleaned and sanitized; 36 37 g. any food or water provided to dogs while on the licensed 38 premises is in a single-use, disposable container; and 39 h. the dog is on a leash or confined in a pet carrier and is under 40 the control of its owner at all times while the dog is present in the 41 designated area of the licensed premises. 42 43 2. This act shall take effect immediately. 44 45 46 **STATEMENT** 47 48 This bill allows dogs in areas of limited breweries that are 49 designated for the consumption of malt alcoholic beverages.

1 Under the bill, dogs are allowed in any area of the licensed 2 premises of a limited brewery that is designated for the 3 consumption of malt alcoholic beverages provided that: 1) the 4 holder of a limited brewery license has elected to allow dogs on the 5 licensed premises; 2) dogs will not have access to any areas of the 6 premises where a dog would present a risk of contamination of 7 products intended for human consumption; 3) the area of the 8 licensed premises designated for consumption of malt alcoholic 9 beverages can be accessed without passing through any areas of the 10 licensed premises where the presence of a dog would present a risk 11 of contamination of products intended for human consumption; 4) 12 the presence of dogs will not present a risk of contaminating any 13 clean equipment, glassware, or related articles in the area 14 designated for the consumption of malt alcoholic beverages; 5) staff 15 members are not allowed to have any direct contact with dogs while 16 on duty, and will be required to promptly wash their hands 17 following any direct contact with a dog; 6) the designated area is 18 maintained in a clean condition, and any surfaces contaminated by 19 dog excrement or bodily fluids are promptly cleaned and sanitized; 20 7) any food or water provided to dogs is provided in a single-use, 21 disposable container; and 8) dogs are required to be on leashes or in 22 carriers and under the owner's control at all times.
