

To Whom It May Concern:

I write to amend my Legislator's Financial Disclosure Statement for calendar years 2005 and 2006. During a routine review of prior years statements both an omission and an error in the earned income section of those statements was noticed. Though properly listed in the business organizations section of both statements, I neglected to list my professional subchapter S corporation (Herb Conaway MD PC) as a source of earned income. Instead I improperly listed Saint Francis Medical Center as a source of earned income in both statements when in fact Saint Francis does not employ me. Rather it employs my professional S corporation.

It is my hope that the committee will properly recognize that these errors and omissions were completely unintentional and do not represent an attempt to keep from the public the information it needs to make well considered judgments as to the qualifications of those privileged to represent them.
