Dear Chairwoman Buono:

We want to thank you for the opportunity to present our budget testimony on April 9<sup>th</sup>. This letter provides responses to your question and those of Senator O'Toole raised at the hearing.

Senator Buono:

- Please provide the committee with the department's interpretation of eligibility criteria, pursuant to P.L.2005, c.375 (C.17:48-6.19 et al.) in light of information contained in the OLS Background Paper, *Continuation of Health Benefits Coverage for Certain Dependents Up to Age 30*, (page 12 OLS Budget Analysis). The background paper asserts that, among the criteria for coverage of a young adult (under age 30) after "aging out" of his or her parent's coverage, "the criteria that a dependent 'is not provided' health benefits coverage from any other source, means that the dependent is not *actually covered*, as opposed to merely being *eligible* for coverage, by another source." Does the department agree with this interpretation? Or, is it the department's interpretation that mere eligibility for coverage under another plan renders that individual ineligible for coverage pursuant to P.L.2005, c.375?

**Response:** The Department agrees with OLS that a dependent qualifies for coverage under P.L. 2005, c.375 even if he is eligible for coverage under another plan and that only actual coverage under another plan results in disqualification. P.L. 2005, c.375 defines a dependent as a child by blood or law who is:

- (1) under 30 years of age,
- (2) unmarried,
- (3) has no dependents of his or her own,
- (4) is a resident of New Jersey or a full-time student, and
- (5) "**not actually provided coverage** under any other group of individual health benefits plan, group health plan, church plan or health benefits plan, or entitled to benefits under Title XVIII of the Social Security Act". i.e. Medicare.

The Department has concluded that item (5) of the above definition of dependent establishes that a dependent who is eligible for other coverage may be covered under c.375 continuation, except that eligibility for Medicare disqualifies him or her from c.375 continuation.

Banking

The majority of fines collected are related to unregistered solicitor violations. Other fines collected in this area are for Annual Report penalties, examination fees, NJHOSA penalties, and miscellaneous fees (replacement checks).

Insurance

The major categories for the fines were misappropriation of client or company funds, submission of dishonored checks, failure to notify the Department of indictments or convictions, and submitting false information on various types of applications, and conducting business without the proper licensing authority.

## Real Estate Commission

Some examples of violations of the statute are using escrow account monies for purposes not permitted under the law; poor accounting for all monies held or expended by the licensee; failure by the broker of record or employing broker to properly supervise a salesperson; failure to maintain proper supervision of a branch office; advertising practices that do not strictly comply with the statute or are deceptive.

- Please provide the committee with detailed expenditures of the department's "Upward Mobility Program." Please detail the expenditures by: individual; class or program taken; and school or other educational facility.

*Response:* Several years ago the Department of Banking and Insurance established a lunch time college program for our employees. Our support staff approached us regarding career paths to the professional titles in the Department. All of these titles require a college degree as a minimum. As a result of those requests we began a college degree program with Mercer County Community College. Most of the courses are given at lunch time in our facility. Employees in the program are required to pass the courses with at least a C or they must pay for the course themselves.

Since it started eighteen employees were able to earn their Associate's degree from Mercer County College. Seventeen female employees, seven who are minorities, were among those who received their degrees. Many were able to be promoted as a result of earning their degrees.

Mercer County Community College has an alliance with Fairleigh Dickinson University which allows our employees to apply all of their credits from Mercer to a Bachelor's degree from Fairleigh Dickinson. Classes are given at our facility during lunch.

The program with Fairleigh Dickinson is limited to reimbursement for tuition for three courses per year.

Nine of our staff who completed the Mercer program have enrolled in Fairleigh Dickinson. Two have already earned their Bachelor's degree and two more will complete their studies in June.
