The following represents Treasury's responses to questions raised during the hearing before the Assembly Budget Committee on March 25, 2008:

**Assemblyman Cryan:**

**QUESTION:** How many executive branch employees would be excluded from the possible early retirement program based on the restrictions you will propose?

**ANSWER:** Based on the data available at the time of the budget, there were approximately 3,200 direct care workers that would be excluded from an Early Retirement Incentive Program (ERI). However, the final form of an ERI program has not been decided, therefore, any estimate of the number of employees exempt is premature.

**Assemblywoman Quigley:**

**QUESTION:** How many individuals perform functions of State employees (as contractors or in other arrangements) but are not State employees?

**ANSWER:** At this time we do not have the data necessary to answer this question. As information becomes available, we will forward a response.

**Assemblyman Malone:**

**QUESTION:** List all tax and fee increases in calendar years 2006 and 2007.

**ANSWER:** Please see Attachment A for a preliminary listing. We are awaiting information concerning any Department of Environmental Protection fees.
